


Strategic Alignment with County Priorities

The efforts support Ramsey County's commitment to:

- Residents First
 - Ensuring accessible, effective, and responsive services
- ❖ Racial and Health Equity
 - Addressing systemic disparities
- **❖** Justice System Transformation
 - Centering community and well-being in public safety
- Holistic Support
 - Strengthening youth and families with coordinated care





Background: Healing and Support for Justice-Involved Youth and Families

- Youth from African American, Native American, Hispanic, and Asian communities in Ramsey County are more likely to be impacted by the justice system.
- There is strong support from state, county and community leaders to invest in violence prevention programs and services for justice-involved youth and their families.
- ❖ Ramsey County secured a \$10 million direct appropriation through the 2023 Public Safety Omnibus Bill (Laws 2023, Chapter 52).
- ❖ In 2024, Ramsey County launched two crossdepartmental initiatives, led by HWST, CCD, Social Services, and Safety & Justice, in partnership with:
 - Ramsey County Attorney's Office and Sheriff's Office, whose advocacy helped secure critical state funding.




Youth Treatment Homes – \$5 Million

- Establish culturally driven, trauma informed homes.
- Homes to be safe, community-based, and culturally aware.
- Young people will stay there by court order to get therapy and healing support.
- Families and community members will help guide the program.
- Funding expires June 30, 2027.

Violence Prevention & Family Support – \$5 Million

- Support local groups that help youth and families.
- Help families when a young person is placed outside the home.
- Offer short-term care to avoid youth going to jail.
- Create job programs for youth involved in the justice system.
- ❖ Funding is accessible until June 30, 2027.



Overview: Healing and Treatment Homes

- ❖ Purpose: Establish safe, stable, and healingcentered homes that deliver culturally responsive care tailored to the needs of justice-involved youth and their families.
- ❖ Investment: \$4.38 million awarded to two qualified service providers committed to equity and community well-being.
- ❖ Use of Funds: To develop homes that prioritize healing, cultural connection, and long-term support.
- Community Level Impact: Safer, more resilient communities by reducing youth incarceration and fostering healing through culturally grounded, family-centered care.



Timeline: Healing and Treatment Homes




Healing and Treatment Homes: Advancing Goals by Filling Gaps

Goals:

- Provide safe, stable, and healing-centered homes for justice-involved youth.
- * Reduce detention through trauma-informed, culturally responsive care.
- Engage families and communities in youth rehabilitation.
- Support justice system transformation through community-based alternatives.
- Establish a scalable, sustainable model with long-term funding potential.

Gaps Addressed:

- ❖ Lack of culturally appropriate residential options.
- Overuse of detention and inappropriate placements (e.g., hospitals, JDC).
- Disconnected services across justice, health, and family systems.
- Barriers to reintegration and family-centered support.
- Short-term, crisis-focused approaches without long-term impact.




Long-Term Sustainability/Resource Planning

A workgroup has been exploring strategies to secure long term funding beyond the grant timeline - ensuring sustainability, advocating for policy change, and adapting programs for long-term success.

Sustaining Funding for Youth Programs:

- ➤ Licensing and State Funding: Revenue streams will depend on DHS licensing. The main funding stream will be Title IV-E.
- ➤ **Diversion:** Children are currently in hospitals and other locations where SSD pays for them. Funding could shift between current options to YTH.
- ➤ Partnering with others: Regional partners have placement challenges and have indicated they are interested in using Ramsey County beds.
- > New Opportunities: Working with the partners to identify grants and other non-traditional funding sources.
- > Work with the State: Meet with state partners to look at ways to get enhanced per diem rates, explore other funding options and possible new legislation.





Violence Prevention Services Grant

Overview: Violence Prevention Services Grant

- ❖ Purpose: To fund violence prevention services across six areas.
- ❖ Investment: \$4.4 million focused on supporting youth and families
- Use of Funds:
 - * \$2M to complement the healing and treatment homes care and rehabilitation.
 - * \$825K to expand respite and alternatives to detention services.
 - * \$820K to innovate and expand access to Safety and Justice programs.
 - * \$425K to support youth leadership, economic mobility, and well-being.
 - ❖ \$180K to support youth empowerment and workforce development.
 - ❖ \$150K to strengthen youth and family-focused community supports.
- ❖ Community Level Impact: Strengthens community safety and youth well-being through expanded, culturally responsive prevention and support services.



Violence Prevention: Advancing Goals by Filling Gaps

Goals:

- Prevent youth justice system involvement through early, community-based interventions.
- Expand access to culturally responsive prevention and support services.
- Promote youth leadership, empowerment, and economic mobility.
- Provide alternatives to detention and crisis placement.
- Strengthen families and communities to increase long-term safety and well-being.

Gaps Addressed:


- Limited investment in youth-centered violence prevention.
- Few alternatives to detention or emergency placement for at-risk youth.
- ❖ Lack of coordinated, community-led prevention infrastructure.
- Underrepresentation of youth voice, leadership, and workforce pathways.
- Disparities in access to supportive services for marginalized communities.

Performance and Evaluation

The core areas Ramsey County will be evaluating to understand the effectiveness of healing homes and violence prevention programs are:

Implementation: Are these programs being delivered as intended, and are targeted populations receiving program services?

Engagement: How effectively are these programs engaging justice-involved youth and their families and what barriers are limiting access and participation?

Impact: Are these programs reducing violence and fostering healing for youth and families?

Summary: Transforming Justice-Involved Youth Services

What Makes This Work Unique

- First-of-its-kind healing-centered care plus justice transformation at the county level.
- Developed outside traditional systems, aligned with community priorities.
- Moving forward amid structural, cultural, and financial challenges.

Key Pillars of the Work

- ❖ \$10M state investment supporting Healing & Treatment Homes and Violence Prevention.
- Equity-driven and culturally responsive.
- Multi-phase implementation with cross-sector collaboration.
- Focus on youth healing, family support, and community well-being.
- Pursuing long-term sustainability via licensing, state partnerships, and funding diversification



Breaking New Ground: A Transformative Youth Justice Model
