


Legislative Platform Development: Then and now

	Last time (2025 session)	This time (2026 session)
Session start	Jan 14, 2025	Feb 17, 2026
Biennium year	Budget year	Policy and bonding year
What to expect	State fiscal pressures, special elections, late start in House	State and federal fiscal pressures, positioning for mid-term elections
Starting point	Built off previous year's platform.	Started from scratch with full re-evaluation of old platform items; development of new items.
Development process	Departments completed proposal form; GR met with directors and SMEs to discuss proposals. Met with commissioners 1:1.	Cross-departmental Legislative Platform Advisory Teams (LPATs) developed platform items collaboratively. Met with commissioners 1:1.
Final approval	Nov 19, 2024	Nov 18, 2025 (planned)

Framework for 2026 Legislative Priorities

Legislative platform development has been guided by the same priorities that framed the budget process:



Legislative Platform Advisory Teams (LPATs)

- Nine teams based on specific legislative areas.
- Bring together cross-departmental leaders and SMEs with Government Relations, Racial and Health Equity Administrators, and Policy & Administrative Strategy.
- Collaborate to identify priorities for legislative platforms.
- Coordinate review and approval of platform items.
- Prepare GR staff to advocate knowledgably for platform items.

Government Relations engages with legislators and partners like AMC throughout the year. For the 2026 Session, we will need:


- A tight focus on the most critical legislative priorities, and what is urgent and realistically achievable—less is more.
- An emphasis on supporting county responsible services.
- Strong commissioner engagement with legislators.
- “Hot topic” presentations for legislative delegation pre-Session.
- Leveraging partnerships wherever possible.
- Engage in Special Session (mental health, local control) if it happens.
