Joint Powers Agreement with Dakota County for Tuberculosis Control Services

Recommendation

1. Approve the Joint Powers Agreement with Dakota County for Ramsey County to provide tuberculosis control services to Dakota County residents for the period of January 1, 2026 through December 31, 2027, in the not to exceed amount of \$70,000.
2. Authorize the Chair and Chief Clerk to execute the agreement.

Background and Rationale

In 2023, Dakota County Public Health reached out to Saint Paul - Ramsey County Public Health for a first time ever Joint Powers Agreement to provide tuberculosis control services to Dakota County residents. Saint Paul - Ramsey County Public Health is requesting to continue the Joint Powers Agreement to provide tuberculosis (TB) detection, prevention and treatment services to clients residing in Dakota County, who have been referred by Dakota County Public Health. These tuberculosis control services include TB skin testing; chest x-rays; laboratory services; physician evaluation, consultation, diagnosis, and treatment; medication dispensing and monitoring; follow-up services; and additional diagnostic services. Clients with active or latent TB will be referred to Saint Paul - Ramsey County Public Health for services and will work with Dakota County Public Health to ensure that the continuation of services will occur until clients are successfully treated.

Ramsey County bills third party payers for all services provided. For clients who are uninsured, Dakota County will reimburse all services rendered at the Ramsey County's board approved rate during the term of the contract. Other reimbursements include \$1,700 a year for interpreter costs and a one-time fee for case management services for each TB client referred who does not have insurance coverage. Ramsey County does not receive any other administrative payment for services rendered.

County Goals (Check those advanced by Action)

Well-being Prosperity Opportunity Accountability

Racial Equity Impact

TB disproportionately impacts people who are within congregate settings, including correctional facilities, drug treatment centers, nursing homes and homeless shelters. Foreign-born persons, including children are highly impacted by TB. Control and management of TB is critical to prevent the further spread of TB within communities most impacted.

Community Participation Level and Impact

Residents of Dakota County who are referred to Saint Paul - Ramsey County Public Health will be informed of eligibility to receive TB control services.

The \$70,000 is included in the approved 2026-2027 Public Health budget.

**JOINT POWERS AGREEMENT BETWEEN
THE COUNTY OF DAKOTA AND THE COUNTY OF RAMSEY
FOR TUBERCULOSIS CONTROL SERVICES**

This Joint Powers Agreement ("Agreement") is between the County of Dakota, by and through Dakota County Public Health ("Dakota") and the County of Ramsey, by and through St. Paul-Ramsey County Public Health ("Ramsey"). This Agreement uses the word "parties" for both Dakota and Ramsey.

WHEREAS, Dakota and Ramsey are governmental units as that term is defined in Minn. Stat. § 471.59.

WHEREAS, Minn. Stat. § 471.59 authorizes local governmental units to jointly or cooperatively exercise any power common to the contracting parties.

WHEREAS, Dakota requires Tuberculosis Control Services for its residents.

WHEREAS, Ramsey operates a Tuberculosis Control program and is able to provide those program services to Dakota under the terms of this Agreement.

WHEREAS, the parties desire to cooperate in providing Tuberculosis Control Services as more fully described herein.

WHEREAS, the parties previously entered into a Joint Powers Agreement dated 12/24/2025 for tuberculosis services to be provided in 2026 and 2027, which the parties now desire to replace with this Agreement.

NOW, THEREFORE, in consideration of the mutual promises and covenants herein, Dakota and Ramsey hereby agree as follows:

1. **Purpose.** The purpose of this Agreement is to set out the respective duties and responsibilities of Dakota and Ramsey for the provision of Tuberculosis Control Services, as more fully described herein. This Agreement shall replace the parties' Joint Powers Agreement for tuberculosis services dated 12/24/2025. The parties agree to waive any termination notice required under section 7 of the prior agreement. Notwithstanding the date of the parties' signatures, this Agreement shall control the parties' responsibilities for all tuberculosis services provided effective January 1, 2026 through the term of this Agreement and the parties' prior agreement dated 12/24/2025 shall have no force or effect.
2. **Term.** This Agreement shall be effective on January 1, 2026 and shall continue in effect through December 31, 2027, unless earlier terminated by law or according to the provisions of this Agreement.
3. **Ramsey Obligations.** Ramsey agrees to provide the Tuberculosis Control Services identified on Exhibit 1 to Dakota County residents who have been referred to Ramsey from Dakota County Public Health.
4. **Dakota Obligations.** Dakota may refer residents to Ramsey for Tuberculosis Control Services under this Agreement. Dakota will pay Ramsey for such Services provided to Dakota residents as set forth on Exhibit 1. Dakota shall only be obligated to pay for Tuberculosis Control Services for Dakota residents referred to Ramsey for such Services by Dakota County Public Health. If Ramsey identifies a client as a Dakota resident, Ramsey shall notify Dakota and Dakota may make a referral. Payment does not prevent Dakota from disputing the claim. Payment of a claim is not a waiver, admission, release, ratification, satisfaction, accord, or account stated by Dakota. The maximum amount to be paid by Dakota pursuant to this Agreement shall not exceed \$70,000.
5. **Liability.** Each party to this Agreement shall be liable for the acts of their own officers, agents, volunteers, or employees and results thereof to the extent authorized by law and shall not be responsible for the acts of the other party, its officers, agents, volunteers, or employees. It is understood and agreed that the provisions of the Minn. Stat. § 471.59, the Municipal Tort Claims Act, Minn. Stat. Ch. 466 and other applicable laws govern liability arising from the parties' acts or omissions. Each party represents that they are able to comply with this section through an insurance or self-insurance program

and that each has minimum coverage consistent with the liability limits as stated in Minn. Stat. Ch. 466. The parties shall promptly provide Notice in writing and in reasonable detail of any demand, action, suit, or proceeding against the party providing Notice relating to this Agreement or the provision of Tuberculosis Control Services under this Agreement. The provisions of this section 5 shall survive the expiration or termination of this Agreement.

6. **Data Practices.** The parties agree that any information and data received from the other party during the term of this Agreement shall be treated and maintained in accordance with all applicable federal, state, and local laws, rules and regulations governing same, including but not limited to the provisions of the Minnesota Government Data Practices Act, Minnesota Statutes, Chapter 13. To the extent permitted by law, if either party receives a request to release the data received from the other party, the party which has received the data request must promptly notify the other party. In connection with any data received from the other party under this Agreement, each party shall provide the other party with prompt Notice of a breach of the security of such data as defined in Minn. Stat. § 13.055, subd. 1(a) or suspected breach of the security of data and shall assist in remediying such breach. The provisions of this section 6 shall survive expiration or termination of this Agreement.

7. **Termination.**

7.1 **With or Without Cause.** This Agreement may be terminated with or without cause, by either party upon (30) calendar days' written notice to the other party of intent to terminate.

7.2 **Non-Appropriation of Funds.** Notwithstanding any provision of this Agreement to the contrary, this Agreement shall be terminated immediately by either party in the event a party determines sufficient funds from the County, State, or Federal sources are not appropriated at a level sufficient to allow payment of the amounts due for the performance of this Agreement or to provide the Tuberculosis Control Services.

8. **General.**

8.1 **Authorized Representatives.** The following named persons are designated the Authorized Representatives of the parties for purposes of this Agreement. The Authorized Representative, or their successor, has authority to bind the Party they represent to the extent such authority has been granted by the Party's governing body. The Parties shall promptly provide Notice to each other when an Authorized Representative's successor is appointed.

8.2 **Liaisons.** The following named persons are designated the parties' Liaisons for purposes of this Agreement. The Liaison, or their successor, has authority to assist the parties in the day-to-day performance of this Agreement, ensure compliance, and provide ongoing consultation related to the performance of this Agreement. The parties shall promptly provide Notice to each other when a Liaison's successor is appointed. The Liaison's successor shall thereafter be the Liaison for purposes of this Agreement.

8.3 **Notices.** Any notices required or permitted to be given under this Agreement shall be delivered personally or sent by U.S. mail to the other party's Authorized Representative, with a courtesy copy provided by email. The parties may provide written notification to each other of any change to the designated Authorized Representatives or contact information.

8.4 **Amendments.** No amendments or variations of the terms and conditions of this Agreement shall be valid unless in writing and signed by the parties' authorized representatives.

8.5 **No Joint Venture.** It is agreed that nothing in this Agreement is intended or should be construed as creating the relationship of agents, partners, joint ventures, or associates between the parties or as constituting Ramsey or Dakota as the employee of the other entity for any purpose or in any manner whatsoever.

8.6 **Minnesota Law to Govern.** The laws of Minnesota govern all matters related to this Agreement, without giving effect to the principles of conflict of law. Venue for all legal proceedings arising out of this contract, or breach thereof, shall be in the state or federal court with competent jurisdiction in Minnesota.

8.7 **Compliance with Applicable Law.** The parties agrees to comply with applicable federal, state and local laws or ordinances, and applicable rules, regulations, and standards established by any agency of such governmental units, which are now or hereafter promulgated insofar as they relate to the parties' performance under this Contract and to the facilities, programs, and staff for which the parties are responsible. Ramsey shall procure and maintain all licenses, certifications, registrations, permits, or other rights required to perform the Tuberculosis Control Services under this Agreement.

8.8 **Survival.** The provisions of this Agreement which, by their terms, impose obligations that are continuing in nature and which must survive in order to give effect to their meaning will survive the expiration or termination of this Agreement.

8.9 **Authority.** The person or persons executing this Joint Powers Agreement on behalf of Ramsey and Dakota represent that they are duly authorized to execute this Joint Powers Agreement on behalf of the respective parties and represent that this Joint Powers Agreement is a binding obligation and is enforceable in accordance with its terms.

8.10 **Assignment and Delegation.** Neither party shall assign its rights or delegate its duties under this Agreement without receiving the prior written consent of the other party.

8.11 **Severability.** In the event that any portion of this Joint Powers Agreement shall be held to be invalid, such invalidity shall not affect the validity of the remainder of this Agreement.

8.12 **Electronic Signatures.** Each party agrees the electronic signatures of the parties included in this Contract are intended to authenticate this writing and to have the same force and effect as wet ink signatures.

IN WITNESS THEREOF, the parties have caused this agreement to be executed intending to be bound thereby.

Exhibit 1 – Service Description and Payment Terms

Saint Paul - Ramsey County Public Health (Ramsey) shall provide tuberculosis (TB) detection, prevention and treatment services to clients residing in Dakota County, who have been referred by Dakota County Public Health (Dakota). These tuberculosis control services include:

- TB skin testing; QFTs (QuantiFERON Blood Test)
- Chest x-rays;
- Laboratory services:
- Physician evaluation, consultation, diagnosis and treatment;
- Medication dispensing and monitoring.
- Follow-up services, e.g. physician visits, nurse visits, additional lab and x-ray services;
- Additional diagnostic services
- Summary of services after each visit to be emailed to the responsible staff person in County;
- Phone or in-person interpretation as necessary to serve Dakota residents with English as a second language and the deaf or hard of hearing
- Notification of no-shows to the responsible staff person in Dakota after each incident.

Ramsey will accept all usual and customary TB referrals made by the Dakota. Ramsey will also provide services for uninsured and underinsured Latent TB Infection (LTBI) cases. Authorization for the above services by the Dakota will be via the Dakota TB Referral and Follow-up Report Form. Ramsey may see referred LTBI clients up to three (3) visits without additional prior approval from the Dakota for all services listed above, except tuberculosis skin testing and additional diagnostic services.

Dakota will be responsible for follow-up with referred clients whose medical needs exceed the scope of services provided by the Ramsey and will assist them in finding low-cost health services, applying for emergency Medical Assistance (MA), etc.

Ramsey shall complete their portion of the Dakota TB Referral and Follow-up Report Form, and provide copies of all laboratory and x-ray results to Dakota Public Health staff. Ramsey shall retain possession of the x-ray; however, the x-ray shall be sent to a physician for comparison upon request.

Reimbursement for Services

Ramsey shall bill the Dakota on a quarterly basis. Statements shall be itemized by client, only for those TB and interpreter services for Dakota residents that Ramsey is unable to recover from third party sources, Dakota agrees to pay Ramey County's board approved rate for services during the term of the contract for all TB services.

Dakota agrees to pay Ramsey \$1700 a year for interpreter costs

Ramsey will bill a one-time fee based on Ramey County's board approved rate for case management service for each TB client referred who does not have insurance coverage.

Inclusion, Diversity and Equity

The Dakota embraces and supports person-centered practices and expects Ramsey to do the same. Person-centered practices are structured in a way to support a client's comfort and ability to express choice, control, and direction in all aspects of service delivery and support. While the nature of some services and service deliveries is such that it must account for factors beyond the client's choice, control and direction, including, but not limited to, the terms of this Agreement, court orders, the safety of the client and others, and governing law, the Dakota values consideration of the client's perspective, knowing that services are more efficient and effective when aligned with client choice. [For more information, refer to Person-Centered, Informed Choice and Transition Protocol, Minnesota Department of Human Services, issued 3/27/17 and updates.]

The Dakota further recognizes that pervasive racism, discrimination and other institutional and community biases, as well as harm from historical trauma, are experienced by cultural communities and that this may

contribute to overrepresentation of cultural communities in some Dakota services. Appropriate service delivery often requires open discussion considering the real-life experiences of the people served, paying attention to the impact of pervasive racism and bias. At the referral level, it means inquiring with families about how to integrate their family or individual culture into service delivery. At the service level, it includes attention to outcomes for families receiving services in order to assess whether effectiveness differs in cultural communities and responding to any differences.

It is expected that while performing services for the Dakota, the Ramsey shall abstain from unacceptable behaviors including, but not limited to:

- Racial, ethnic or discriminatory jokes or slurs;
- Hostile, condemning, or demeaning communications, both verbal and written;
- Behavior demonstrating disrespect, dishonesty, intimidation, or disruption to the work relationship; and
- Retaliation against any person who reports or addresses unacceptable behavior.

It is the responsibility of the Ramsey to ensure staff delivering services for the Dakota are aware of these expectations and trained as needed to ensure respectful, cooperative and professional conduct in interactions with Dakota staff and clients. If the Dakota experiences or receives a report of an unacceptable behavior, it will share the report with Ramsey. The Ramsey must inform the Dakota of steps taken to remedy the unacceptable behavior within ten (10) working days. If the unacceptable behavior persists, the Dakota may terminate the Agreement pursuant to the termination provision in the Agreement.

Title

Correction to 2026-27 Public Health Fee Schedule

Recommendation

Approve the revised fee schedule for 2026-27 Environmental Health and Clinical Services Fee Schedule.

Background and Rationale

Public Health's Environmental Health and Clinical Services divisions operates several programs that rely on license fees, clinical service fees, vaccination/medication fees, and other fees to cover regulatory expenditures as well as expenditures for services performed by the clinic. The Ramsey County Fee Schedule in the 2026-27 budget was approved by the Ramsey County board in December 2025, but did not include the updates and proposed changes submitted by Environmental Health and Clinical Services. The proposed changes to be approved are attached.

Since 1990, Environmental Health programs for licensing and related regulatory activities have been license-fee funded. (Resolution 90-634). The fees generated for regulatory activities do not receive any tax, levy or state funds. Portions of the programs that are not related to licensing and inspection are funded with County Environmental Charge funds.

The following Environmental Health programs have license fees associated with them:

- Community Environmental Health
- Food Establishments
- Lodging Establishments
- Manufactured Home Parks
- Public Swimming Pools Solid & Hazardous Waste Compliance
- Hazardous Waste Generators
- Hazardous Waste Facilities
- Solid Waste Facilities Solid Waste Operations
- Very Small Quantity Generator collection

Clinical Services fees have been an integral part of providing services to the community for our clinic that allow residents to receive services for little to no-cost. These fees are established by evaluating private market rate through insurance as well as Public Managed Assisted Program. These fees include the cost of medication, services and supplies.

Racial Equity Impact

The racial equity impact of departments, programs and services is included in the 2025-2026 Biennial Budget documents and was previously discussed during the budget hearings in September of 2025. There is no

known racial equity impact for Environmental Health. Clinical Services fees are evaluated to ensure that there are no barriers to accessing care.

Community Participation Level and Impact

Each service team held budget engagement sessions with staff from their respective service teams. In addition to staff engagement sessions, Ramsey County held community budget townhalls to share information on the county's budget process and county priorities. The sessions included questions and answers as well as community feedback segments.

Fiscal Impact

The corrected fee schedule should collect sufficient funds to meet revenue expectations in the approved 2026-2027 budget. The magnitude of the correction cannot be estimated because total fee revenue can vary considerably from year to year, based on several factors. Those factors include the number of establishments that open and close, waste volumes generated, etc. There have been years when, despite a change in limited fees, the revenue target was not reached and other years when it was exceeded.

Clinical Service Fees are collected to cover the cost of care, in the approved 2026-2027 budget.

Last Previous Action

On December 16, 2025, the County Board adopted the current fee structure when it approved the 2026-2027 Operating Budget (Resolution B2025-246).

Title

2025 Budget Adjustment for the Lake Owasso Residence

Recommendation

Authorize the County Manager to transfer up to \$2 million of General Fund fund balance to the 2025 Lake Owasso Residence Enterprise Fund.

Background and Rationale

In 2025, Lake Owasso Residence (LOR) is projected to exceed the available budget by \$2 million, approximately 15% of total expenditures, primarily due to increased overtime costs.

In 2025 the average number of vacancies at LOR was 20 Full Time Equivalent (FTE), representing 19% of total authorized FTEs for the facility. LOR is a 24-hour facility which is home for up to 64 adults with developmental and intellectual disabilities. There are staffing ratios, required by the state and federal government, which need to be met to provide care to the residents. Due to vacancies and the need to meet the staffing ratios, overtime was used throughout the year. The cost of overtime for 2025 is projected to be \$2 million, which is over budget by \$1.4 million. The remaining shortfall is in supplies, groceries, furniture and other non-personnel costs for the homes and a slight shortfall in revenue due to a reduced census of 60 residents.

The leadership team at LOR is working on a plan to address the long-term staffing needs and reduce overtime use in 2026. Currently there are 12.00 vacant FTEs, which is an improvement over 2025.

The requested transfer of up to \$2 million from unrestricted General Fund fund balance will ensure adequate funding exists for all outstanding expenses to close the 2025 budget year.

According to the Minnesota Department of Human Services women, people of color and immigrants are disproportionately represented in the direct care workforce compared to overall populations. LOR is no exception to this statistic. There is also a shortage of direct care staff in Minnesota which affects the number of vacant FTEs.

There is no community participation associated with this action.

Fiscal Impact

This transfer will reduce the county's unrestricted General Fund fund balance for 2025. The county will still be

in compliance with the requirements for the fund balance amount. This is a one-time transfer of funds in 2025 and does not increase the budget in future years.

On February 1, 2022, Ramsey County Board of Commissioners approved Ramsey County Care Center and Lake Owasso Residence General Fund Balance Transfer to Close 2021 Enterprise Funds (Resolution B2022-041).

2025 Budget Adjustment for the Ramsey County Attorney's Office

Recommendation

Authorize the County Manager to transfer up to \$750,000 from the General Fund fund balance to the Attorney's Office 2025 operating budget for salary and benefit costs, professional services, and attorney services and administrative costs.

Background and Rationale

In 2025, the Ramsey County Attorney's Office (Attorney's Office) is projected to exceed available appropriations by \$3.2 million or 5.8% of the total expenditures, primarily due to increased salary and benefit costs associated with prosecutorial duties of the Attorney's Law Office. This request is a one-time authorization for a transfer of funds to the 2025 budget and does not increase the Attorney's Office budget in future years.

During 2025, the Attorney's Office, Office of Safety & Justice, and Finance met to review spending and monitor the budget, including reviewing quarterly year-end projections. Throughout the year, the Attorney's Office worked toward reducing the amount that would be needed at year end by managing its spending throughout the year, leveraging grants and other revenue sources, and engaging in other efforts to manage the 2025 budget.

Throughout 2025, the personnel services budget was monitored closely. Even though the office has experienced a significant number of vacancies, the personnel services budget is approximately \$2.7 million over budget. Additionally, professional services is projected to be over budget by approximately \$500,000 due to costs for executing the prosecutorial duties of the Attorney's Office. Specifically, significant caseloads continue to be experienced by the County Attorney's Office and has resulted in increased costs for: outside counsel, investigative support for the prosecution teams, process services and attorney and administrative services costs for the Child Support Program.

The total expenditure deficit of \$3.2 million for 2025 in the Attorney's Office is off-set by approximately \$2.0 million in revenue that is expected to be received above the approved 2025 Attorney's Office revenue budget and a budget transfer of \$450,000 from the approved county budget for anticipated personnel services expenditures.

The Attorney's Office is now requesting up to \$750,000 from the General Fund fund balance. The requested transfer is an up to amount to ensure adequate authority exists to cover all outstanding costs and close the books for the county for budget year 2025. The Attorney's Office will work with Finance to finalize all transfers.

Effective and transparent use of taxpayer dollars is critical to ensuring trust, accountability and transparency for Ramsey County and the Attorney's Office. For this 2025 budget adjustment, the community participation level is to inform. However, there have been many opportunities for community to share input on the county's budget during every biennial budget development process. Community input on spending priorities and results are always welcomed and encouraged.

Fiscal Impact

For reference, the 2025 approved levy, before approved negotiated bargaining increases, was \$33.89 million for the County Attorney's budget. This action will reduce the county reserves; however, the county will remain in compliance with its fund balance policy.

Last Previous Action

On December 17, 2024, the Ramsey County Board authorized the County Manager and the Chief Financial Officer to transfer up to \$1,000,000 to the Ramsey County Attorney's Office 2024 budget from the General Fund fund balance (Resolution B2024-281).

Title

Allocation of Grant Funds from the Minnesota Department of Public Safety towards the Acquisition of Youth Healing and Treatment Homes.

Recommendation

1. Approve the allocation of Minnesota Department of Public Safety grant funds toward the acquisition of Youth Healing and Treatment Homes in the amount of \$1,950,000.
2. Authorize the County Manager to enter into the necessary loan or other agreements and execute amendments to loan or other agreements in a manner consistent with local regulations and requirements, in a form approved by the County Attorney's Office.

Background and Rationale

Ramsey County's youth justice reforms are rooted in nearly two decades of intentional system transformation focused on reducing detention, addressing racial disparities, and expanding community-based alternatives to out-of-home placement. These efforts culminated in a 2023 legislative appropriation to support the development of culturally specific, trauma-informed youth healing and treatment homes, informed by community engagement and statewide recommendations to create more individualized, community-centered systems of care.

Through cross-county and state collaboration, several bills were authored and passed with direct appropriations for Ramsey County. The focus of this Request for Board Action is an appropriation made in Laws 2023, Ch. 52, Public Safety Omnibus Bill, which states:

(h) Ramsey County Youth Treatment Homes Acquisition and Betterment

\$5,000,000 grant to Ramsey County to establish, with input from community stakeholders, including impacted youth and families, up to seven intensive trauma-informed therapeutic treatment homes in Ramsey County that are licensed by the Department of Human Services, that are culturally specific, that are community-based, and that can be secured. These residential spaces must provide intensive treatment and intentional healing for youth as ordered by the court as part of the disposition of a case in juvenile court.

Following the board's acceptance of the grant award in May 2024, the county conducted a structured solicitation in accordance with county procurement policies and procedures to identify qualified client services providers to partner with the county and capable of meeting programmatic, licensing, and community requirements to establish one or more youth treatment homes. Resulting client services agreements are currently under final negotiations and will be fully executed prior to the loan or other agreements being executed by the county.

Under these partnerships, in addition to the contracted amount specified in the client service agreements, this allocation of funding will facilitate full financing in the form of forgivable 10-year mortgages. The county's interests in each loan will be secured through execution of a Promissory Note, a recorded Mortgage, and

Declarations that will be recorded against the properties and which shall reserve for the County the first option to repurchase at the fair market value at the time of repurchase, i.e., right of first refusal.

All homes will be funded in compliance with applicable state and local regulations, using financing documents approved by the County Attorney's Office. The acquisition of each home will be subject to required contingencies prior to execution of the financing documents, including execution of the services agreements; approval of the Purchase Authorization by the county; completion and approval of county inspections; and receipt of provisional zoning approval prior to closing. Additionally, the county will continue working with the Minnesota Department of Human Services (DHS) to build strong relationships and frameworks to support providers through the licensing process, which can only occur after the purchase is complete.

By authorizing the County Manager to execute the necessary loan, financing, and related agreements, the county will be positioned to respond efficiently to identified housing opportunities. This authority will support timely investment in the identified need for treatment capacity rather than long-term property management, strengthen community-based provider infrastructure, and advance the County's goal of keeping youth closer to their families and communities while delivering intensive therapeutic services.

Financing the acquisition of healing and treatment homes directly aligns with and advances Ramsey County's long-term racial equity goals by addressing persistent and well-documented disparities in the youth justice system. Black, Indigenous, and other youth of color continue to be disproportionately represented among youth requiring court-ordered placement. This partnership and investment of the proposed home purchase for treatment services, informed by demographic data and priorities, supports a trauma-informed, culturally specific, community-based model of care that keeps youth closer to family, culture, and community supports. By shifting resources away from institutional settings and toward neighborhood-based healing and treatment homes, this action advances racial equity, strengthens community infrastructure, and contributes to more equitable outcomes for youth most impacted by system involvement.

Community Participation Level and Impact

Through the solicitation process referenced above, the importance of culturally responsive care, individualized treatment, strong family and community connections, and healing-centered environments was emphasized. These insights directly informed the planning, program design, and site selection for the proposed healing and treatment home. Program owners and service providers will help ensure that operations remain aligned with community-identified priorities, demonstrating meaningful participation and reinforcing a community-informed, culturally responsive approach for the long-term.

Inform Consult Involve Collaborate Empower

Fiscal Impact

The resulting agreements and corresponding financing are supported entirely by state-allocated grant funds awarded to the county. There is no county tax levy included in this request. Sustainability of the services provided will be supported through a combination of revenue sources, including Title IV-E, potential utilization of county beds by regional partners, and the shifting of funds to this service area from other Social Services hospital and placement costs. In addition, future efforts will be made to pursue grant opportunities, nontraditional funding sources, and state support, as well as to seek enhanced per diem rates and explore legislative options.

On May 7, 2024 the Ramsey County Board of Commissioners approved award of Therapeutic Youth

Treatment Homes grant (Resolution B2024-078)

On July 23, 2024, The Ramsey County Board of Commissioners approved the amendment to the grant agreement with Minnesota Department of Public Safety for Therapeutic Youth Treatment Homes (Resolution B2024-144)

On August 12, 2025 the Ramsey County Board of Commissioners hosted a board workshop to discuss the planning and implementation of treatment homes.

Big Stories from 2025

Record Year for West Nile

- 45 Human Cases (previous record = 28)
- 25,000 Mosquitoes Tested, 18.7% were positive
- Disease activity peaked earlier than normal.



Cattail Mosquitoes Return

- Highest number collected since 2020.
- Numbers peaked the week of July 8th.
- Extra treatments kept them below projection.



Spring Mosquitoes Absent

- 2023 set a record, 2024 was close behind, and 2025 had very few.
- Low precipitation in spring was likely the cause.





Most common used active ingredients were *Bti* (1.32 million lbs) and Methoprene (0.25 million lbs)




Adult Control

Fewest acres of Adult Control in 25 years.

Adult control using a backpack applicator or truck/ATV mounted cold fogger is primarily used to suppress disease vectors.

Primary active ingredients used are Permethrin and Etofenprox.

Plans for 2026

Tire Procedure for 2026

Recycling waste tires is an important way to remove potential mosquito habitat. MMCD has had a tire recycling program for decades.

Recently, the number of requests have been increasing and there has been strain on staff time and resources.

In 2025 Dakota, Scott, and Carver Counties piloted tire drop-off events in lieu of residential pickups. This removed more tires while also saving staff time.

This will be expanded to all counties in 2026. Look for dates of the 2026 Ramsey County events coming soon!





Adult control materials are used sparingly and safely by trained staff.





2025 Activity Summary for Ramsey County

MOSQUITO CONTROL

Most efforts by MMCD are to control mosquito larvae that develop in standing water and are most common after rain. Treatments use dry granules that are specific to mosquito larvae and are not harmful to people, pets, or wildlife. Materials are applied via helicopter, backpack, drone, or by hand. Adult mosquito control is done sparingly, usually in areas of elevated disease risk.

Adult Mosquito Control in 2025:

Acres Treated: **666.14**



DISEASE PREVENTION

Controlling the mosquito species that are most likely to spread disease is a top priority for MMCD. Removing containers that could hold stagnant water is critical to reducing the spread.



The Big Stories from 2025

RECORD YEAR FOR WEST NILE VIRUS

Minnesota reported the third highest number of human infections of West Nile virus in the nation in 2025. In the Twin Cities, we experienced our highest number of human cases on record with 42 reported, greatly surpassing the previous high of 28. Several factors contributed to this increase including a high number of *Culex tarsalis* mosquitoes, which are the primary species responsible for WNV transmission, and high infection rates among mosquito pools appearing earlier than normal. MMCD took several steps to respond to this increase in disease activity including additional surveillance locations, targeted control measures in areas with elevated infection rates, and expanded media appearances and public outreach.

CATTAIL MOSQUITO SURGE IN JULY

After 4 years of below average mosquitoes in July, the mid-summer surge was back in 2025 with the highest reported total of one particular species in the Twin Cities since 2020. Cattail mosquitoes (*Coquillettidia perturbans*) are a unique species that overwinters as larvae below the ice attached to vegetation (often cattail plants) before emerging the following summer around the beginning of July. Due to excessive rain in 2024 our entomology lab model predicted a high number (about 88/trap) in 2025. While the actual number was much higher than the previous 3 years, which each saw about 15/trap, the number in 2025 came in lower than the prediction at about 41/trap, thanks in part to targeted treatments by MMCD field staff.



BLACK FLY TOTALS WERE LOW IN 2025

The number of biting black flies collected in sweep nets in 2025 (0.45/sweep) was lower than 2024 (1.13/sweep) and 2023 (0.9/sweep), due in part to lower river levels in the spring and a record number of small stream treatments done by MMCD in 2025.

DEER TICKS ABUNDANT IN EAST AND NORTH

METRO

Blacklegged ticks or “deer ticks” are collected by MMCD staff by trapping small mammal hosts, by dragging cloths across the forest floor, and by removing ticks found on themselves after being outdoors. In 2025, the highest number of blacklegged ticks were found in northern Anoka County and throughout Washington County. American dog ticks or “wood ticks” were most abundant in Dakota County.
