Background and Rationale:

On December 1, 2020 the Legislative Committee of the Whole met and reviewed a draft of the 2021 Ramsey County Federal Legislative Platform, which had been prepared by the Government Relations staff. The draft contained earlier changes suggested by the members of the board at the County Board Workshop on November 10th. The Legislative Committee of the Whole approved the proposed platform as presented and asked staff to incorporate changes based on the discussion around mental and behavioral health. Additionally, the 2021 Federal Legislative Platform draft includes Legislative Guiding Principles, Ramsey Funding and Policy Priorities, and a statement of support for platforms of the National Association of County Officials (NACO).

The Legislative Committee of the Whole recommends the draft of the Ramsey County Federal Legislative Platforms to be submitted to the County Board, as summarized below:
