

Transformation of the TIP

Where we were:

- ~\$35m program.
- No long-range plan, limited priorities.
- Simple process, constrained by funding.
- No corridor studies.
- Transit separate from Public Works.

Where we are going:

- ~\$100m program.
- 2050 All Abilities Plan adopted.
- Transit and Transportation Investment Plan approved.
- Major corridor approach.
- Values-driven.
- Transit integrated into program.
- New processes needed to scale.

Ramsey County's plans guide:

- TIP project selection.
- Transportation Sales and Use Tax CIP.


TIP implementation.



All-Abilities 2050 Plan

- Guiding document for how projects are prioritized in the TIP.
- Based on four priorities:
 - Safety.
 - Equity.
 - Pedestrian and bicycle.
 - Pavement condition.





All-Abilities 2050 Plan

- Key outcome: Identified the need for Edgerton Street corridor study:
 - Highest equity need.
 - Critical crash rate above 1.
 - Regional bike route & crosses barriers.
 - Fair pavement condition, fix now or rebuild at much higher cost later.
- Also confirms need for:
 - White Bear Avenue study.
 - Maryland Avenue study.






Transit and Transportation Investment Plan

- Guides allocation of future funding for:
 - Regional Railroad Authority Levy.
 - County Transportation Sales and Use Tax.







Transit and Transportation Investment Plan

Key outcome: County Transportation Sales and Use Tax eligible projects in the 2026-2030 TIP:

- Rice Creek Boulevard.
- Corridor studies:
 - Larpenteur Avenue.
 - White Bear Avenue.
 - Maryland Avenue.
- Purple Line, Union Depot to Maplewood Mall.
- Hwy 96 intersections.
- And more.





Economic Competitiveness and Inclusion Plan

- A More Resilient and Equitable Community.
 - Strategy 1 measure of success:
 Increase in multi-family housing near transit corridors.
 - Strategy 3 measure of success:
 Increase in the number of Naturally Occurring
 Affordable Housing units preserved along
 transit and commercial corridors.





Economic Competitiveness and Inclusion Plan


- A More Economically Competitive Community:
 - Strategy 8 measure of success:
 Increased investment in businesses operating in key transit and commercial corridors.
- Key outcomes:
 - Prioritizing projects with high equity need.
 - Business communication during construction.
 - Investing in transit to spur affordable housing development.





Climate Equity Action Plan


- Area of Focus: Clean Transportation
 - **Goal 1:** Plan a network that supports sustainable, multi-modal transportation.
 - Goal 2: Make it equitable and easier for all ages and abilities to use the multi-modal transportation network.
 - **Goal 3:** Reduce transportation-related greenhouse gas emissions within the county.



Climate Equity Action Plan



- Key outcomes:
 - Prioritizing multi-modal projects.
 - Funding trail projects including Bruce
 Vento Trail with Parks & Recreation.
 - Reducing greenhouse gas emissions will be a priority of Hwy 96 intersection designs.
 - Resilient stormwater infrastructure to adapt to changing climate.



Developing Initiatives

- At-grade rail crossings.
 - Cooperative venture with railroads.
- Passenger rail expansion.
- Union Depot sustained funding.
- Tree planting program.
