The Bands will be special, limited revenue obligations of the HRA, and the Bands and interest thereon will be payable solely from the revenues and assets expressly pledged to the payment thereof. No holder of any Band will have the right to compel any exercise of the taxing power of the HRA or Ramsey County to pay the Bands or the interest thereon, nor to enforce payment against any assets or property of the HRA or Ramsey County except money payable by the Borrower to the HRA and pledged to the payment of the Bonds. Before issuing the Bonds, the HRA will enter into an agreement with the Borrower, whereby the Borrower will be obligated to make payments at least sufficient at all times to pay the principal of and interest on the Bonds when due.
