- 3. Authorize the County Manager to execute amendments to the agreement in accordance with the county's procurement policies and procedures, in a form approved by the County Attorney Office, provided the amounts are within the limits of available funding.

#### **Background and Rationale**

In 2018, Kimley-Horn was hired to complete preliminary and final construction plans and a long-range plan amendment. A single source professional service agreement was approved to complete the remaining design, for construction plan finalization, special provisions/specifications finalization, right-of-way approval, completion of federal aid documentation, agency coordination, project permitting with appropriate agencies, construction bidding assistance, and design assistance during construction for the term from July 20,2023 through July 19, 2026, in the amount of \$168,338.

Effective May 26, 2023, Ramsey County Single Source Purchase Policy requires that single source contracts with amendments which cause the contract to go over \$175,000, must be approved by the county board.

During project activities, unforeseen design and project permitting impacts occurred which resulted in additional design services needed for; stormwater management, wetland impacts, a second pedestrian bridge, and site related improvements within the railway corridor. The cost for this additional work resulted in an increase of \$222,550 exceeding the \$175,000 cap for single source agreements.

#### First Amendment to PRK136

This is an Amendment to an Agreement between Ramsey County, a political subdivision of the State of Minnesota, on behalf of Parks & Recreation, 2015 North Van Dyke, Maplewood, Minnesota 55109 ("County") and Kimley-Horn and Associates Inc, 1010 Dale Street North, Saint Paul, MN 55117, registered as a Corporation in the State of Minnesota ("Contractor" or "Kimley Horn").

In this Amendment, changes to pre-existing contract language will use strikethrough for deletions and **bolding and underlining** for insertions.

# 1. The parties agree to amend the Agreement as follows:

Additional work tasks associated with project elements developed over the course of the project finalization, MnDOT approvals and agency permitting, as well as complete construction observation and administration services.

#### Revision 1: Section 1.1 is amended as follows:

#### **Term**

#### 1.1.

The original term of this Agreement shall be from July 20, 2023 through **December 31, 2027** July 19, 2026 and may not be renewed.

#### Revision 2: Section 2.1 is amended as follows:

#### 2.1

Project related tasks and scope of services activities for the Bruce Vento Phase 1 section consist of construction plan finalization, special provision/specifications finalization, right-of-way approval, completion of federal aid documentation, agency coordination, project permitting with appropriate agencies, construction bidding assistance, and design assistance during construction.

Overall schedule for key milestones:

- Final Draft Construction Documents: Submit draft project memorandum, final draft construction plans, final draft of special provisions/specifications, final draft construction estimate, and associated reporting documents to MN/DOT State Aid no later than September 15, 2023.
- Final Construction Documents: Submit final project memorandum, final construction plans, final special provisions/specification, final construction

estimate and associated reporting documents to MN/DOT State Aid no later than April 2024.

Refer to Attachment A - Scope of Services for detailed project scope of services and tasks. Scope of Services Attachment A is attached and made a part of this Agreement.

#### 2.1.1 Task 1 – Construction Plan Finalization

#### A. Pedestrian Bridge Addition

- The addition of a pedestrian bridge and modification of the original pedestrian bridge required design and construction document changes to several elements of the project including the following:
  - Alternatives analysis including options matrix, bridge fabricator discussions, and cost estimating to determine path forward.
  - Additional geotechnical borings at the new bridge abutments to determine proposed foundation design in accordance with MnDOT State Aid Bridge design requirements. This work was performed by Braun Intertec as a subconsultant to Kimley-Horn. A copy of Braun's proposed fee and scope of work is included as an attachment to this letter.
  - Design of new bridge abutments for the revised bridge span lengths and locations.
  - Trail alignment revisions to accommodate the new bridge locations and minimize bridge span lengths.
  - Revision of grading, erosion control and restoration plans in the vicinity of the pedestrian bridges.
  - Revision of construction quantities and cost estimate.

#### B. Hoffman Road/TH61 Intersection Design

The proposed modifications at this intersection required design and construction document changes including the following:

- Submittal of official intersection layout in accordance with MnDOT Level
   2 Layout approval requirements, incorporation of comments for approval by the MnDOT Layout Review Committee.
- <u>Preparation of Intersection Control Evaluation (I.C.E) document for</u> MnDOT approval.
- <u>Curb and gutter, sidewalk ramp removals, replacements and realignments at NE, NW, SE and SW quadrants of the intersection.</u>
- Relocation of northwest signal mast arm structure and pedestrian push buttons.
- Relocation of southwest signal mast arm structure and removal of pedestrian push buttons

#### C. Tree Removal Assistance

Additional labor provided to include the following:

• Modifications to the plans, specifications and quantities to remove trees from Federal Aid plan set.

- Preparation of field staking information for County surveyor
- Facilitation of a field walk with County Surveyor (full day)
- <u>Facilitation of field review of tree removals with tree removal contractor (full day)</u>

#### D. Sidewalk Connections

• Incorporate sidewalk connections to include revisions to removal plan, construction plan, grading, drainage and signage and striping plans.

#### 2.1.2 Task 6 – Permitting

- A. RWMWD and Minnesota Department of Natural Resources Permitting
  - Contractor revised original permit applications to incorporate the second pedestrian bridge.

#### B. BNSF Permit and MnDOT ROW Certificate

- Throughout the course of design, Kimley-Horn facilitated several meetings with the BNSF staff to help obtain the necessary permit to construct the trail within the railroad right of way.
- In order to facilitate the BNSF permit agreement Kimley-Horn submitted the required permit fees to the BNSF via their on-line portal. Kimley-Horn is preparing documentation for MnDOT related to ROW acquisition to obtain the ROW Certificate necessary for FHWA approval.

#### Revision 3: Section 4 is amended as follows:

#### 4.1

The County shall pay the Contractor a not to exceed amount of \$160,937.50 383,487.50 over the life of the contract according to the agreed to rates.

#### 4.2

The County shall pay the Contractor the following unit rates:

As outlined in the approved cost proposals which are attached and made a part of this Agreement as Attachment B - Engineering Services Cost Proposal, and Attachment C - Estimate of Cost for Professional Services - Amendment # 1.

#### 4.3

Additionally, the County will reimburse the Contractor for the actual cost of out of pocket expenses incurred in the performance of services under this Agreement, up to a maximum not to exceed payment of \$7,400.00. Each invoice shall have attached to it receipts for expenses for which the Contractor is seeking reimbursement.

#### 4.4

The maximum not to exceed contract sum is \$168,337.50 390,887.50 (\$160,937.50 as set forth in Attachment B, plus \$179,450.00 in labor and \$43,100.00 in fees as set forth Attachment C, plus \$7,400.00 for out-of-pocket expenses as set forth in Section 4.3.)

#### 4.5

Reimbursement of expenses will be made consistent with County policies. The County will reimburse only the actual cost of out of pocket expenses incurred for completion of the project. If reimbursement for travel is permitted, all airfare will first be authorized by the County and will be reimbursed at the lowest cost fare available. Lodging, meals, ground transportation and incidentals necessitated by the resulting contract will be reimbursed according to the Internal Revenue Service ("IRS") Regular Per Diem Rate Method or actual cost, whichever is less. Mileage will be reimbursed at the IRS rate in effect at the time of travel.

**2.** Except as modified herein, the terms of the Agreement shall remain in full force and effect.

#### **Background and Rationale**

The 2024 legislative session appropriated \$500,000 for competitive equity grants to Regional Park Implementing Agencies for new fishing piers to increase fishing opportunities on lakes in the metropolitan parks system. A lottery was held at the Metropolitan Parks and Open Space Commission meeting on February 6<sup>th</sup>, 2025, and the Ramsey County Parks Sucker Lake Fishing Pier application was one of four awarded from a pool of eligible applications.

Fishing at the Sucker Lake section of Vadnais-Snail Lake Regional Park is extremely popular. Currently the only fishing available in this section of the park is either along Sucker channel or the shoreline of Sucker Lake. Because of the limited availability of fishing locations, the channel has collected significant amounts of lead tackle, leading to dozens of swan deaths. www.ramseycounty.us/leadfreelakes

Adding a fishing pier to Sucker Lake will alleviate some fishing pressure at the channel while providing increased fishing opportunities to a diverse community of anglers and accessible fishing access that is missing at this location. Signage would be installed to encourage people at this popular fishing location to visit the pier.

#### **Racial Equity Impact**

Recent community engagement and outreach has shown there to be significant racial diversity of anglers in this area. Spring through fall, families visit Sucker Lake and will often make a day of picnicking and fishing at this park. The Saint Paul Police Activities League (P.A.L.) Cops and Bobbers use this area as part of their youth programming and Ramsey County Parks free Catch & Release programming could be expanded with the addition of a pier.

# **2024 Notice of Funding Availability (NOFA)**

This 2024 Notice of Funding Availability (NOFA) describes the Metropolitan Council's intentions for the one-time legislatively directed Regional Parks System Fishing Piers Grant Program. Specifically, this notice:

- Establishes the amount of funding available and the limits that apply to individual awards.
- Sets the schedule for application submittal, review, and award.
- Describes the criteria the Metropolitan Council will use in project selection.
- Defines who is eligible to apply.

# Background and Purpose

The 2024 legislative session appropriated \$500,000 for grants to Regional Park Implementing Agencies for new fishing piers to increase fishing opportunities on lakes in the metropolitan parks system. The Metropolitan Council is tasked with soliciting proposals from the implementing agencies. These funds expire June 30, 2026.

# Eligible Applicants

By state statute<sup>1</sup>, applicants must be a regional park implementing agency, defined as the counties of Anoka, Carver, Dakota, Ramsey, Scott and Washington, the cities of Saint Paul and Bloomington, the Minneapolis Park and Recreation Board, and the Three Rivers Park District.<sup>2</sup> Regional park implementing agencies are welcome to collaborate on proposals. Individuals and/or other governmental, private, or nonprofit entities are not eligible to apply, but are encouraged to be included as project partners with regional park implementing agencies.

### Available Funds and Award Limits for 2024

- \$500,000 in State funds is available for new fishing piers.
- Agencies are allowed to submit one application each for \$125,000. If the total project cost is more than \$125,000, agencies must provide the additional funding.
- A lottery will be held at a Metropolitan Parks and Open Space Commission (MPOSC) meeting to select four awards from the pool of eligible applications.
- The Council reserves the right to award less than the available funding.
- Grants are reimbursement-based.

# Eligible Uses of Funds and Criteria

Grant proposals must meet all of the below criteria to be considered for funding.

- Proposals must be for new fishing piers.
- Proposals must clearly demonstrate a need and describe how the fishing pier will increase fishing opportunities.
- Proposals must address one or more equity focus area (age, race, ethnicity, income, national origin or ability).
- The proposal must demonstrate how a new fishing pier will contribute to additional programming opportunities and awareness building for the regional parks and trails system.

- Projects must be ready to start so that they can be completed by June 30, 2026.
- Projects must be within the boundaries of the Regional Parks and Trails System, consistent with the 2040 Regional Parks Policy Plan, consistent with a Council-approved long-range plan, and compliant with the Americans with Disabilities Act (ADA).
- Project must be approved by the Agency's locally elected board either individually or as part of a local capital improvement plan before a grant agreement is executed.

# Proposal Review Process

Council staff will review all proposals to ensure completeness and eligibility. Council staff are available to answer agency questions throughout the application process. Applications must meet each of the criteria listed above in order to be eligible for the lottery. The MPOSC chair will select four applications at random at a public MPOSC meeting.

#### Grant Terms

Grants will expire June 30, 2026, with no extensions possible. All costs eligible for reimbursement must be incurred during the grant term and all costs must be submitted within 90 days after the end of the grant term. Unspent grant funds will revert to the State.

#### **GRANT AGREEMENT**

**THIS GRANT AGREEMENT** ("Agreement") is made and entered into on the Effective Date by and between the Metropolitan Council ("Council") and the Regional Park Implementing Agency identified above as the "Grantee."

### **RECITALS**

- 1. The Minnesota Legislature, by Minnesota Laws 2024, Regular Session, Chapter 116, Article 1, Section 5 appropriated funds for State Fiscal Year 2025 from the State General Fund ("Appropriation") to the Council for grants to Regional Park Implementing Agencies.
- 2. Minn. Stat. § 473.301 *et seq.* authorizes the Council to make grants to eligible governmental units situated wholly or partly within the metropolitan area for the purpose of regional recreation open space development in accordance with the Council's 2040 Regional Parks Policy Plan.
- 3. The Grantee sought funding from the Council for its Grant Project from the appropriation. The Grant Project Summary is attached hereto as **Attachment A**.
- 4. The Council authorized the granting of a portion of the Appropriation to the Grantee for the completion of the Grant Project pursuant to the Business Item referenced on Page 1.

5. The Grantee represents that it is duly qualified and agrees to perform all services described in this Agreement to the satisfaction of the Council during the Grant Project Activity Period.

**NOW THEREFORE**, in reliance on the above statements and in consideration of the mutual promises and covenants contained in this Agreement, the Grantee and the Council agree as follows:

#### 1. Definition of Terms.

The terms defined in this section have the meanings given them in this section unless otherwise provided or indicated by the context.

- A. *Approved Long-Range Plan*. "Approved Long-Range Plan" means the long-range plan for the Park required and approved by the Council.
- B. *Council Action*. "Council Action" means the action or decision of the governing body of the Metropolitan Council, on the meeting date identified at Page 1 of this Agreement, by which the Grantee was awarded State General Funds.
- C. *Effective Date:* "Effective Date" means the date this Agreement is fully executed by both parties. Pursuant to Minn. Stat. §16B98, Subd. 7, no payments can be made to the Grantee until this Agreement is fully executed.
- D. *Eligible Costs*: "Eligible Costs" means and is limited to the Use of Funds described in Attachment A.
- E. *Grant Project Activity Period.* "Grant Project Activity Period" is identified on Page 1 of this Agreement.
- F. *Grant Project Summary*. "Grant Project Summary" identifies the Grant Project activities and is attached hereto as **Attachment A**.
- G. *Measurable Outcomes*. "Measurable Outcomes" means outcomes, indicators, or other performance measures that may be quantified or otherwise measured to measure the effectiveness of a project or program in meeting its intended goal or purpose.
- H. *Park.* "Park" means the regional park, park reserve, trail corridor, or special recreation feature in which the Project is to be performed.
- I. *Policy Plan*. "Policy Plan" means the Council's 2040 Regional Parks Policy Plan, including the capital improvement program for recreation open space, required by Minnesota Statutes section 473.147.
- J. *Reimbursement*. "Reimbursement" means the Grantee will expend its own funds and provide to the Council acceptable documentation that the expenditure has been made before seeking payment under this agreement for the expenditure.
- K. *Site Monitoring*. "Site Monitoring" means the Council's review of the Grant Project and records pursuant to Minn. Stat. § 16B.98.
- L. **Small Disadvantaged Businesses.** "Small Disadvantaged Businesses" means small Minnesota-based businesses that are certified as Disadvantaged Business Enterprises (DBEs), Targeted Group Businesses (TGBs), and/or Veteran-Owned Businesses.

#### 2. Survival of Terms.

The following clauses survive the expiration or cancellation of this grant contract agreement: 11. Liability; 12. Audits; 13. Government Data Practices; 15. Governing Law, Jurisdiction, and Venue; 18.2 Publicity; and 18.3 Endorsement.

### 3. Grantee's Duties or Grant Project.

The Grantee will perform the Grant Project listed on Page 1 during the Grant Project Activity Period identified on Page 1.

#### 4. Time.

The Grantee must comply with all the time requirements described in this Agreement. In the performance of this Agreement, time is of the essence.

# 5. Eligible Costs.

- **5.1 Eligible Costs**. Eligible costs are those costs *directly* incurred by the Grantee for Grant Project activities and budget outlined in **Attachment A** taking place during the Grant Project Activity Period that are *solely related* to and necessary for the completion of the Grant Project. This Agreement must be implemented according to Minn. Stat. § 16B.98 and must account for all expenditures.
- 5.2 Ineligible Costs. The Grantee shall not be reimbursed for in-eligible costs. Any cost not defined as an eligible cost or not included in the Grant Project or approved in writing by the Council is a non-eligible cost. Grant funds may not be used for costs of Project activities that occurred prior to the start of the grant project activity period.

### 6. Grant Amount, Payment, and Use.

- 6.1 Grant Amount. The Council will reimburse the Grantee for eligible costs during the Grant Project Activity Period up to the Grant Amount identified on Page 1. This amount is granted for the purpose of performing the Grant Project. In no event will the Council's obligation under this agreement exceed the total grant amount. The Council shall bear no responsibility for any cost overruns that may be incurred by the Grantee in the performance of the Grant Project. Notwithstanding anything to the contrary in this agreement, the payment of State General Fund grant proceeds shall be made by the Council within the time frames specified in this agreement only if the Council has adequate State General Funds on hand at the time that payment is due.
- 6.2 Reimbursement Requests and Documentation. The Council will disburse grant funds in response to a written or electronic payment request submitted by the Grantee to the Council and reviewed and approved by the Council's Authorized Representative. Payment requests shall be made using payment request forms, the form and content of which will be determined by the Council. Payment requests and other reporting forms will be provided to the Grantee by the Council. The Council will disburse grant funds on a reimbursement or a "cost incurred" basis. Payment requests must include the specific Grant Project activities conducted or completed during the authorized time-period. Payment requests must include documentation supporting expenses including consultant/contractor invoices showing the time-period covered by the invoice; proof or verification of payment of the invoice, and other supporting documents as the Council deems appropriate.

- **6.3** Conditions of Payment. All services provided by the Grantee under this Agreement must be performed to the Council's satisfaction, as determined at the sole discretion of the Council's Authorized Representative and in accordance with all applicable federal, Council, and local laws, ordinances, rules, and regulations. The Council will hold the final Grant payment until it receives the completed final project report as referenced in Section 8.2.
- **6.4 Repayment of Unauthorized Use of Grant Funds.** Upon a finding by the Council or the state that Grantee has made an unauthorized or undocumented use of grant funds, and upon a demand for repayment issued by the Council, the Grantee agrees to promptly repay such amounts to the Council. Additionally, if the Grantee is in breach of the requirements of this Agreement, including Minn. Stat. § 16B.98 and MMB's Guidance, the Council may, in its sole discretion, withhold future grants to the Grantee until the breach is cured.
- **6.5 Contracting and Bidding Requirements.** Grantee is expected to follow the contracting and bidding requirements of Minn. Stat. §471.345 and §§177.41 through 177.44 (prevailing wage), if applicable. Grantee may not contract with vendors that are either suspended or debarred in Minnesota: https://mn.gov/admin/osp/government/suspended-debarred/index2.jsp
- **6.6 Disability Access**. Pursuant to the Appropriation, the Grantee should, as part of the Grant Project, in consultation with the Council on Disability and other appropriate governor-appointed disability councils, boards and committees, make progress toward providing greater access to programs, print publications and digital media for people with disabilities.
- **6.7 Regional Use.** The Grantee agrees to develop, operate, and maintain the Park in a manner consistent with the Policy Plan and the park unit's Approved Long-Range Plan, including allowing use of the Park by all persons in the region. The Grantee further agrees that it will not adopt any rules or restrictions hindering or affecting regional use of the Park including, but not limited to, imposing higher fees for non-residents without the express written consent of the Council, either during the Grant Project Activity Period or for a period of twenty (20) years following.
- 7. Accounting, Record-keeping, and Site Monitoring.
  - 7.1 Accounting and Record-Keeping. The Grantee agrees to establish and maintain a separate account for the Grant Project and to maintain accurate and complete books, records, documents, and other evidence pertaining to the costs and expenses of implementing this Agreement to the extent and in such detail that will accurately reflect the total cost of the Grant Project. The Grantee shall use generally accepted accounting principles. Pursuant to Minn. Stat. § 16B.98, all records shall be retained for at least six (6) years after the issuance of the final certificate of acceptance by the Council, or such

shorter period as may be specified in writing by the Council at the expiration of the Grant Project Activity Period.

**7.2 Site Monitoring.** Pursuant to Minn. Stat. § 16B.98, subd. 6, the Council shall monitor Grant Project activities and records.

# 8. Reporting and Grant Closeout.

- **8.1 Semi-Annual Reporting during the Grant Project Activity Period.** Grantee must submit cash flow and semi-annual progress reports to the Council by July 31 and January 31 of each year while the grant agreement is active. In the cash flow report, the Grantee shall describe the current project spending and projected spending for the periods defined in the report template. The progress report shall include the construction, programing and/or consulting activities taken during the reporting period. The Grantee shall provide sufficient documentation for information the Council reasonably requests.
- **8.2 Final Report and Closeout.** Prior to the final reimbursement, the Grantee shall submit to the Council a final project report that provides the completed project results as detailed in the initial measurable outcomes. The Grantee must submit the closeout requirements in a format determined by the Council providing the total Grant Project receipts and expenditures, summarizing all Grant Project activities, and containing a certification by the Grantee's authorized financial representative (e.g.: CFO, Financial Director) that all grant funds were expended in accordance with this Agreement.

#### 9. Changes in Grant Project and Amendments.

- **9.1** Changes in Grant Project. Projects funded by the Appropriation must be substantially consistent in both scope and budget with the approved project description. Changes to the Grant Project in either scope or budget shall require an amendment. Failure to inform the Council of any significant changes to the Grant Project or significant changes to grant-funded components of the Grant Project and any use of grant funds for ineligible or unauthorized purposes, will jeopardize the Grantee's eligibility for future funding.
- 9.2 Amendments. The terms of this Agreement may be changed by mutual agreement of the parties if the changes are consistent in both scope and budget with the approved project description. Changes shall be effective only upon execution of written amendment(s) signed by authorized representatives of the Council and the Grantee. Grant funds for the changed Project will not be disbursed prior to execution of an amendment. If the Grantee needs additional time within which to complete the Grant Project, the Grantee must submit to the Council a written extension request AT LEAST NINETY (90) CALENDAR DAYS PRIOR TO THE EXPIRATION DATE. The combined Grant Agreement with amendments must not exceed five years.

#### 10. Assignment, Waiver, and Agreement Complete.

- **10.1 Assignment.** The Grantee may neither assign nor transfer any rights or obligations under this Agreement without the prior consent of the Council and a fully executed Assignment Agreement.
- **10.2 Waiver.** If the Council fails to enforce any provision of this Agreement, that failure does not waive the provision or its right to enforce it.
- **10.3 Agreement Complete.** This Agreement contains all negotiations and agreements between the Council and the Grantee. No other understanding regarding this Agreement, whether written or oral, may be used to bind either party.

### 11. Liability.

The Grantee must indemnify, save, and hold the Council, its agents, and employees harmless from any claims or causes of action, including attorney's fees incurred by the Council, arising from the performance of this Agreement by the Grantee or the Grantee's agents or employees. This clause will not be construed to bar any legal remedies the Grantee may have for the Council's failure to fulfill its obligations under this Agreement.

#### 12. Audits.

Under Minn. Stat. § 16C.05, subd. 5, the Grantee's books, records, documents, and accounting procedures and practices relevant to this Agreement are subject to examination by the Council and/or the State Auditor or Legislative Auditor, as appropriate, for a minimum of six (6) years from the end of this Agreement.

#### 13. Government Data Practices.

The Grantee and Council must comply with the Minnesota Government Data Practices Act, Minn. Stat. chapter 13, as it applies to all data provided by the Council under this Agreement, and as it applies to all data created, collected, received, stored, used, maintained, or disseminated by the Grantee under this Agreement. The civil remedies of Minn. Stat. § 13.08 apply to the release of the data referred to in this clause by either the Grantee or the Council. If the Grantee receives a request to release the data referred to in this Clause, the Grantee must immediately notify the Council.

#### 14. Workers Compensation.

The Grantee certifies that it is in compliance with Minn. Stat. §176.181, Subd. 2, pertaining to workers' compensation insurance coverage. The Grantee's employees and agents will not be considered Council employees. Any claims that may arise under the Minnesota Workers' Compensation Act on behalf of these employees and any claims made by any third party as a consequence of any act or omission on the part of these employees are in no way the Council's obligation or responsibility.

# 15. Governing Law, Jurisdiction, and Venue.

Minnesota law, without regard to its choice-of-law provisions, governs this Agreement. Venue for all legal proceedings out of this Agreement, or its breach, must be in the

appropriate state or federal court with competent jurisdiction in Ramsey County, Minnesota.

#### 16. Termination.

The Council may cancel this Agreement at any time, with or without cause, upon 30 days' written notice to the Grantee. Upon termination, the Grantee will be entitled to payment, determined on a pro rata basis, for services satisfactorily performed.

### 17. Use of Small Disadvantaged Businesses.

The Council maintains a list of Small Disadvantaged Businesses that the Grantee and its contractors are encouraged to use. This list and technical assistance are available through the Council's Office of Equal Opportunity at <a href="http://mcub.metc.state.mn.us">http://mcub.metc.state.mn.us</a>. The Grantee and its contractors are also encouraged to use Small Disadvantaged Businesses that are certified through other government programs. The Council expects the Grantee and Grantee's contractors to make reasonable efforts to solicit and include Small Disadvantaged Businesses in economic activities that arise from the Grantee's use of grant funds.

#### 18. Miscellaneous.

- **18.1 Minnesota Conservation Corps.** The Grantee shall give consideration to contracting with the Minnesota Conservation Corps for contract restoration, maintenance, and other activities.
- **18.2 Publicity.** Any publicity regarding the Grant must identify the Council as the sponsoring agency and must not be released without prior written approval from the Council's Authorized Representative. For the purposes of this provision, publicity includes notices, informational pamphlets, press releases, research, reports, signs, and similar public notices prepared by or for the Grantee individually or jointly with others, or any subcontractors, with respect to the program, publications, or services provided resulting from this grant contract. All projects primarily funded by state grant appropriations must publicly credit the State of Minnesota, including on the grantee's website when practicable.
- **18.3 Endorsement.** The Grantee must not claim that the Council endorses its products or services.

On August 7, 2022, Bakke was booked into ADC. The Inmate Intake Admission form indicated that Bakke had hemophilia and stitches above his left eye. Medical records available to jail medical staff noted he had a diagnosis as a hemophiliac and presented with schizoaffective disorder. On August 8, 2022, at approximately 4:40 a.m., Bakke was moved to segregation after screaming throughout the night, awakening other inmates, engaging with arguments with other inmates and causing a disturbance in his assigned pod. During the move, Bakke complained of pain and had difficulty walking and was carried by correctional officers. Correctional officers and nursing staff periodically observed Bakke in his cell during routine rounds. On August 9, 2022, at approximately 10:15 a.m., Bakke was found unresponsive in his cell but was breathing on his own. Bakke was transported to the hospital where he remained for 18 days until he passed away on August 27, 2022. Plaintiff's medical expert opined that Bakke died of complications from a spontaneous, catastrophic, intraparenchymal brain hemorrhage caused by his hemophilia. Plaintiff's medical expert further opined that had Bakke been transported to the hospital after showing signs of difficulty walking during the transport to segregation, it could have been lifesaving. 

# **Background**

- Time of unprecedented change.
- Nearly 30% of the counties budget relies on intergovernmental revenues, including critical federal and state grants.
- The rapid issuance of federal Executive Orders is directly impacting state and local government funding.
- Some of these orders are being challenged in court, while others are causing immediate work stoppages and disruptions to federal funding streams.

# Impacts to Minnesota

- Minnesota receives most of its revenue from general taxes, licenses, fees, and federal grants. Approximately 35% of the current state budget is comprised of federal grants totaling around \$42 billion, for the two-year budget.
- The current tracker has \$56.2 million of funds that the state is calling temporary disruptions, as reported by state agencies.
- For the cancelled list, Minnesota
   Management and Budget (MMB) is
   tracking \$299.5 million in cancelled
   federal funds by state agencies.

### **Federal Funding Cuts**

This week, Governor Walz announced <u>a new dashboard Minnesotans can use to track disruptions and cancellations of federal funding</u> and their impact on services available to Minnesotans. Federal disruptions and cuts so far include grants to track measles and avian influenza, provide heating assistance, and mitigate flooding.



Despite court orders prohibiting the federal government from freezing many funding streams, <u>disruptions to federal funds</u> have continued. Some disruptions are short-lived. Other grants and awards are abruptly canceled altogether, resulting in layoffs and fewer services for Minnesotans.








Looking at total award, what the county has spent, and what remains in current awards


