**Notice of Public Hearing and Comment Period for
SUBSTANTIAL AMENDMENT TO FY2024 ANNUAL
ACTION PLAN**

This notice is to announce a public hearing and the beginning of a thirty-day (30) public comment and review period of a proposed amendment to the Ramsey County portion of the Dakota County Consortium 2024 Annual Action Plan. A public hearing will be held on Friday, January 17, 2025 from 4:00 p.m. to 5:00 p.m. at the Roseville Library located at 2180 N. Hamline Ave, Roseville, MN 55113. The hearing will be available online and linked via www.ramseycounty.us/publichearings where a copy of the draft amended 2024 Annual Action Plan will be available for review.

Comments may also be submitted through January 20, 2025 via email to askCED@co.ramsey.mn.us or mailed to Community and Economic Development, 15 West Kellogg Boulevard Suite #250, Saint Paul, MN, 55102. A printed copy of the 2024 Annual Action Plan will be available at this address. CDBG funding in the amount of \$183,000 will be recommended to fund an elevator modernization at the Pioneer Manor senior housing building in White Bear Lake. This would be a new project/activity in the FY2024 Annual Action Plan. Funds for this proposed activity will come from prior years' 2019 and 2021 unallocated funds as well as unallocated 2023 and 2024 program income. This also amends the 2019, 2021, 2023 and 2024 Action Plans. The amendment will be considered by the Ramsey County Housing and Redevelopment Authority on Tuesday, January 21, 2025, immediately following the County Board in the Council Chambers, 15 West Kellogg Boulevard, Saint Paul.
