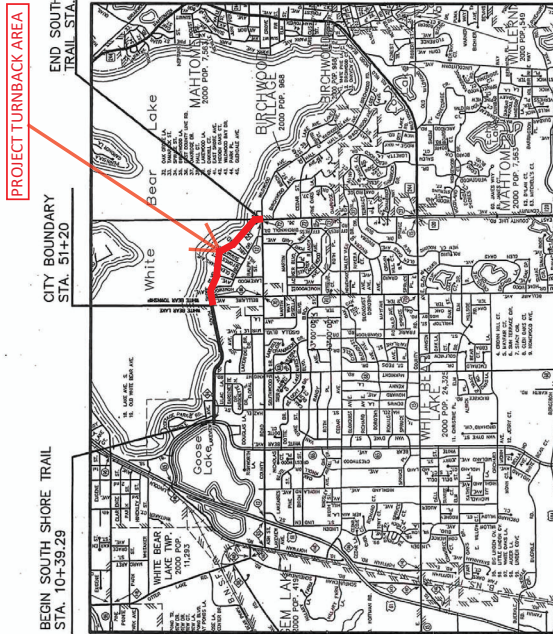


PROJECT LOCATION
