

History of Juvenile Detention Alternatives Initiative (JDAI) in Ramsey County

Youth Justice Challenges in Ramsey County

Double-bunking/Overcrowding

Community Concerns around disparities (DMC)

2800-3500 annual admissions

Lack of detention assessment tools

Detention for status offenses

In 2005, prior to adopting the framework of Juvenile Detention Alternatives Initiative (JDAI), Ramsey County Juvenile Detention Center (JDC) detained all youth engaging in delinquency and annual admissions consistently exceeded 2,000.

Intervention from Ramsey County Board of Commissioners

Under the leadership of Commissioner Carter, community leaders, and Ramsey County Board of Commissioners, Ramsey County adopted the JDAI national framework from the Annie E. Casey Foundation.

Covenants

- Purpose: Reduce unnecessary detention & outof-home placements.
- Establish alternatives to detention (ATD).
- Detention only for youth at risk of reoffending (public safety) or failure to appear (FTA).
- Prioritize public safety, positive youth outcomes and equity.
- ❖ Development of the objective screening tool risk assessment instrument (RAI) to assess appropriate setting for youth engaging in delinquency.












Expansion of JDAI to Deep End Transformation (2018)






Juvenile Probation



Alternatives/Placements.


- 6. Probation Violations and Warrant Cases.


