October 21, 2025



## **Goals of This Workshop**

- Review proposed 2026 legislative priorities and framework.
- Review and provide input on 2026 advocacy strategy.
- Provide feedback on proposed platform to be approved by the Legislative Committee of the Whole on November 4.

## Recap from September 23 Board Workshop

- Government Relations provided platform development update.
- County Board requested:
  - Focused set of top legislative priorities to consider today.
  - Plan for topic-specific briefings for Ramsey County legislators ("Hot Topics").
  - Create an advocacy framework that clearly identifies issues for active leadership and pursuit.
  - Additional resources for commissioner engagement with legislators.

## **Active Advocacy: Responding to Unprecedented Shifts**

- NACo identified unprecedented shifts impacting local governments.
  The stakes have never been higher—demanding new approaches and recalibrated responses that balance evolving responsibilities.
- Persistent property tax pressure.
- Our Path Forward
  - Agility in adapting to changing conditions
  - Opportunities to take ownership and to participate in emerging and urgent conversations
  - Laying the right foundation to be ready for any and all solutions
  - Balancing relationships while preserving our fiscal health
- Next Step
  - Launch of the New Human Services Advocacy Team
    - Led by the County Manager to strengthen alignment, coordination and proactive engagement.

# Ramsey County's Overarching Themes in 2026

No new unfunded mandates.

Protect counties from further cuts.

Counties must be at the table for any service delivery change.

Reduce reliance on property tax.

# Top Legislative Priorities in 2026

- Impact: are critical to Ramsey County services or operations
- Viability: have a chance of success within current political and fiscal conditions
- Indicated with a (!) in this presentation.

## **Bonding Items**

- 2026 is a bonding year (no guarantee of a bonding bill).
- On Oct. 7, County Board approved two bonding priorities.
- Bonding requests are based on:
  - Alignment to strategic priorities, racial equity impact and opportunity
  - Clear vision
  - Previous momentum
  - Legislator buy-in and support
  - External factors such as community input and competing requests

#### Pursue Items

**Pursue** means Ramsey County takes the lead works with the bill sponsor to get the bill jacketed and introduced. Ramsey County may co-lead with another partner. The issue mainly affects only the County and/or no other entity is leading. Requires a substantial investment of time and resources from the County.

## Leading Advocate Items

- Another county, coalition, or association is pursuing the bill or leading opposition.
- As a **Leading Advocate**, Ramsey County provides active advocacy efforts but is not the primary lead.

# **Priorities Led by Ramsey County Attorney's Office**

RCAO would take the lead on the following items, supported by Ramsey County Government Relations.

#### **Proposed Platform Item**

Remove automatic cost-of-living adjustments for maintenance and child support orders in favor of routine reviews, as required by federal regulations, enhancing fairness & improving compliance.

Require employers to report new hires of 1099 independent contractors to DHS, which will help increase child support payments and enhance the fairness of child support orders.

**Increase funds in the state auto theft fund** for advanced prevention and intervention efforts.

#### **Federal Platform**

- Defend against funding cuts and identify bipartisan legislative opportunities that we can support.
- Potential platform items:
  - Delay implementation of changes to SNAP and Medicaid.
  - Preserve funding for Emergency Management, Continuum of Care, and Community Development Block Grant (CDBG).
  - Affordable Housing (e.g., Road to Housing package, including bill from Sen. Smith to streamline CoC funding process).
  - Rule/policy changes to allow streamlining of MnCHOICES reassessments.
  - Transportation and infrastructure funding opportunities.


