County Transportation System Overview

- 293 centerline miles
 - 842 lane miles
- Average Daily Traffic (ADT): 100 to 34,000+ vehicles per day (vpd)
 - Average ADT 9,500 vpd
- 60 county owned bridges
- 300+ miles of sidewalks / trails along county roads
- 25+ miles of bicycle lanes on county roads
- Over 30,000 signs
- 413 traffic signal systems
- 5 rectangular rapid flashing beacons
- Over 12,000 drainage structures/systems
- 4 Transitways
 - Green Line
 - Gold Line
 - Rush Line
 - Riverview





2021 Transportation Projects

Federal and State Bond Funding

Regional Solicitation

- Submitted 8 applications
- Awarded 1 – Maple Ave Pedestrian Bridge over I-94

Highway Safety Improvement Program

- Submitted 2 applications
- Awarded 2 – University Ave RRFB's and Dale St from Como to Highway 36

Local Road Improvement Program

- Submitting 2 applications – Lexington Ave from CR E to I-694 and Old Highway 8 from CR D to 5th St
- Awarded - TBD

Federal COVID Relief Bill

- Process still yet to be determined in allocation / distribution of funding
