

This notice is to announce the beginning of a thirty-day (30) public comment and review period of a proposed amendment to of Ramsey County portion of the Dakota County Consortium 2025 Annual Action Plan. The comment period for the Substantial Amendment to the FY2025 Annual Action Plan will run from January 15, 2026- February 16, 2026. The public hearing for comment will be held in person on February 12, 2026, from 3:30 p.m. – 4:30 p.m., at the Roseville Library in the Community Program Room: 2180 Hamline Ave N, Roseville, MN 55113. It will be available online and linked via: ramseycounty.us/PublicHearings. The 2025 Annual Action Plan Substantial Amendment will be considered by the Ramsey County Housing and Redevelopment Authority on February 17, 2026, immediately following the County Board meeting in the Council Chambers, 15 West Kellogg Boulevard, Saint Paul, MN 55102. The purpose of the public comment period and hearing is to receive comments from the general public concerning the proposed housing and community development needs and objectives of Ramsey County and the proposed use of FY2025 Community Development Block Grant (CDBG) and program income derived from CDBG.
