

**AMENDMENT 14 TO AGREEMENT BETWEEN RAMSEY COUNTY
AND KIMLEY HORN AND ASSOCIATES INC.**

WHEREAS, Ramsey County ("County") and (Kimley Horn and Associates, Inc., 2550 University Avenue West Suite 238N Saint Paul, MN) ("Contractor") entered into an Agreement dated May 22, 2014, for TCAAP Site Redevelopment Infrastructure Development and Design ("Agreement") for consultant services; and

WHEREAS, Prior amendments revised to include miscellaneous strategic advising support as needed in the form of engineering and project management services that may include meeting attendance, stakeholder coordination, analysis of various development scenarios, analysis, and exhibit preparation. The new amendment will increase the contract time; and

WHEREAS, The parties wish to add Amendment 14 to the PW2014-24 agreement to extend the end date for the period of two years from December 31, 2020 through December 31, 2022

Therefore, the parties agree to amend the Agreement as follows:

1. Agreement to extend the end date for the period of two years from December 31, 2020 through December 31, 2022.
2. The insurance requirements are modified as follows:
 - a. Commercial General Liability Insurance limits are as follows:
 - \$ 1,500,000 per occurrence
 - \$ 2,000,000 general aggregate
 - \$ 2,000,000 products/completed operations total limit
 - \$ 1,500,000 personal injury and advertising liability
 - b. Professional Liability/Errors and Omissions Insurance limits are as follows:
 - Professional Liability/Errors and Omissions Coverage
 - Per Claim \$ 500,000
 - Per Occurrence Limit: \$1,500,000
 - Aggregate Limit: \$2,000,000
5. Except as modified herein, the terms of the Agreement shall remain in full force and effect.
