### **County Transportation System Overview**

- 293 centerline miles
  - 842 lane miles
- Average Daily Traffic (ADT): 100 to 34,000+ vehicles per day (vpd)
  - Average ADT 9,500 vpd
- 60 county owned bridges
- 300+ miles of sidewalks / trails along county roads
- 25+ miles of bicycle lanes on county roads

- Over 30,000 signs
- 413 traffic signal systems
- 30+ rectangular rapid flashing beacons
- Over 12,000 drainage structures/systems
- 4 Transitways
  - Green Line
  - Gold Line
  - Purple Line
  - Riverview




#### **Pavement Preservation**

- 8 separate locations
- 8 miles of bituminous road resurfaced
- 2.25 miles of bike lanes
- 2 accessible signals
- 111 ADA ramps

### Pedestrian / Bicycle

- 6 separate locations
- 1 Pedestrian refuge median
- 19 Rectangular Rapid Flashing Beacons (RRFBs)

- 2 projects moved to 2024 to accommodate 2022 Project Completion

# Federal Funding for Transportation - Infrastructure Investment and Jobs Act (IIJA)

- New discretionary grants and grant programs (including, but not limited to)
  - Bridge Investment Program (in addition to bridge formula program)
  - Safe Streets and Roads for All (vision zero)
  - Congestion Relief
  - Electric Charging and Fueling Infrastructure
  - Rural Surface Transportation
  - Reduction of Truck Emissions
  - PROTECT Program (Anti-Defamation League)
  - Healthy Streets
  - Reconnecting Communities
  - Wildlife Crossings
  - Culverts
  - Strengthening Mobility and Revolutionizing Transportation
  - Climate Change
  - Resiliency
  - Equity



### **State Funding for Local Transportation**




- General Obligation (GO) Bond Funds or General Funds
- Transportation programs via statutes
  - Local road improvement program (competitive)
  - Local bridge replacement program (first-in, first-out)
  - Safe Routes to School (competitive)
  - Active Transportation
     Program (competitive)
- Direct appropriation from legislature



### **County Funding for Transportation**

- CSAH Funds
- Wheelage Tax
- Regional Railroad Authority Levy
- Local Option Sales Tax for Transportation and Transit
- CIP Bond Funds
- Motor Vehicle Leased Sales Tax





### **County Wheelage Tax**



- Counties given authority to adopt tax for transportation
- Tax per registered vehicle in the county in which it resides
- Ramsey County Board adoption in 2013 (\$10) and 2017 (increased to \$20)
- Priorities of pavement preservation, ped/bike, ADA, traffic signals, drainage, bridge maintenance, roadway appurtenances
- Capital and operating budgets



# Regional Railroad Authority (RRA) Levy



- Ramsey County RRA was created in 1987
- Dedicated to a long-range vision of transit services to meet changing needs for today and for subsequent generations
- Primary focus on Green Line, Gold Line, Purple Line, and the Riverview Corridor
- Capital and operating budgets



# Local Option Sales Tax (LOST) for Transportation and Transit

- Counties given authority to adopt 0.5% sales tax and \$20 per motor vehicle
- Must identify specific projects for use of funds
- Ramsey County Board adoption in 2008 as part of Counties Transit Improvement Board (CTIB) and then in 2017 as part of CTIB dissolution
- Primarily capital budget
- Adopted uses include: Green Line; Gold Line; Purple Line; Riverview Corridor; Pedestrian, bike and trail projects; and any project included in the TIP



# Capital Improvement Program (CIP) Bond Funds

 \$2M annually for pavement preservation

### Motor Vehicle Leased Sales Tax (MVLST)

- Created in 2008
- Distribution
  - 38% to the county state-aid highway fund;
  - 38% to the greater Minnesota transit account;
  - 13% to the Minnesota state transportation fund; and
  - 11% to the highway user tax distribution fund.
- 38% to CSAH fund goes to 7 metro counties, excluding Hennepin and Ramsey Counties, based on population percentages

### **Other Funding Participation**

- Cost participation from cities, counties, watersheds, MnDOT, or other agencies
- Cost participation policy is adopted every year with the approval of the 5-year TIP.
- Typical cost sharing items:
  - Right of way acquisition
  - Storm sewer (by contributing flow)
  - Traffic signals
  - Retaining walls
  - Sidewalks/trails
  - Engineering and construction administration
