Background and Rationale

Ramsey County has received Community Development Block Grant (CDBG) funding as an "urban county" for more than 25 years. The U.S. Department of Housing and Urban Development (HUD) provides these annual grants to "develop viable urban communities by providing decent housing, a suitable living environment, and by expanding economic opportunities, principally for low and moderate-income persons". The Dakota County Consortium is the "participating jurisdiction" for Ramsey County's receipt of HOME Investment Partnerships Act Program Funds (HOME), which are limited to projects providing affordable housing. The Consortium consists of Anoka, Dakota, Ramsey and Washington Counties, as well as the city of Woodbury.

The Consolidated Plan, required by HUD, guides the investment of entitlement CDBG and HOME Funds over a five-year period. The Consolidated Plan is designed to help states and local jurisdictions assess their affordable housing and community development needs and market conditions, and to make data-driven, place-based investment decisions. The consolidated planning process serves as the framework for community members and organizations to provide input and identify housing and community development priorities that align and focus funding. The Consolidated Plan is carried out through Annual Action Plans, which provide a summary of the actions, activities, and the specific federal and non-federal resources that will be used each year to address the priority needs and specific goals identified in the consolidated planning process. Ramsey County reports on accomplishments and progress towards Consolidated Plan goals in the Consolidated Annual Performance and Evaluation Report. The 2023-24 Annual Action Plan will be the fourth annual plan of the current five-year Consolidated Plan.

The 2023-24 Annual Action Plan/Proposed Use of Funds addresses needs of low and moderate-income persons in the suburban Ramsey County service area. Overall priorities for the use of funds, including countywide housing rehabilitation, public services related to housing instability and investment in affordable

multi-family housing development and preservation, are after consultation with suburban municipalities, which participate in the Ramsey County Entitlement Program and community partners each year. The plan addresses the statutory requirements for receiving annual entitlement funds from HUD and is consistent with department strategies to foster prosperity and access to opportunities.

Projects recommended for funding in HUD's Fiscal Year 2023 (July 1, 2023-June 30, 2024) are consistent with the current Consolidated Plan. Ramsey County anticipates receiving a 2023 allocation of \$1,202,421 in CDBG funding and \$593,806 in HOME funding from HUD. In addition, Ramsey County has \$283,219 in unspent HOME funds from prior years and \$91,829 in HOME program income. The total available HOME funding is \$968,854.

Racial Equity Impact

In Ramsey County, Black/African American, American Indian and other residents of color are more likely to be renters than White residents. Renters of color and American Indian residents are more likely to be cost-burdened by housing costs than White residents. According to the Mapping Prejudice Project and the Economic Competitiveness and Inclusion Plan, Ramsey County also has one of the largest homeownership gap between White residents and Black residents in the nation. Strategic investments in affordable rental and owner-occupied housing by the county can help reduce these racial disparities in housing. Furthermore, HOME-funded units are 100% affordable and subject to rigorous fair housing requirements. This prohibits discrimination by direct providers of housing, such as landlords and real estate companies, whose practices make housing unavailable to persons because of race or color, religion, sex, national origin, familial status or disability.

Community Participation Level and Impact

Goals and objectives for CDBG and HOME funds are set during the consolidated planning process, following the community outreach and participation strategies required by that plan. As required two public meetings were held to gather community input and the recommended projects and a public notice was given in the local newspaper. The meetings occurred on February 7, 2023 and May 8, 2023. Additionally, projects were selected through the 2023 Housing Development and 2023 CDBG Public Services, Programs and Facilities Solicitations, which was designed with input from community providers and governmental partners. The engagement findings and recommendations are laid out in the associated Deeply Affordable Housing Initiative Engagement Report.

Fiscal Impact

Community & Economic Development, in partnership with the County Attorney’s Office and Finance, solicited for eligible activities through two competitive solicitations. The 2023 Housing Development Solicitation was open to projects the expanded or preserved the supply of affordable housing and the 2023 CDBG Public Services, Programs and Facilities Solicitation. The process for selection included a review for eligibility and completeness, an interdepartmental scoring team and independent financial analysis for housing development projects. All projects included in the Annual Action Plans/Proposed Use of Funds were selected through this process. Future CDBG processes will be informed by procurement modernization efforts which aim to create countywide policies and procedures for grant processes.

The total amount of CDBG funding available for the 2023-24 HUD fiscal year is \$1,202,421, a decline of \$12,948 from the previous year’s entitlement grant. No additional CDBG program income or unspent funds from previous years were available for the 2023-24 Annual Action Plan. The total amount of HOME funding available for the 2023-24 HUD fiscal year is \$968,854 including program income and unspent funds from previous years. This is a decline of \$220,848 from the previous year due to less available program income.

2023-24 CDBG and HOME funding become available through HUD and the Dakota County HOME Consortium on July 1, 2023.

Last Previous Action

On May 10, 2022, the Housing Redevelopment Authority approved the 2022 Community Development Block Grant-HOME Investments Partnerships Act Annual Action Plan/Proposed Use of Funds (Resolution H2022-007).

Narrative Project Descriptions of Proposed Use of Funds for the 2023 Annual Action Plan

Housing Acquisition Rehabilitation

Hearts and Hammers **\$10,000**
Suburban county-wide **CDBG**

Hearts & Hammers will use funds to purchase supplies for the projects, supplies for volunteers to complete the project, and operational and personnel overhead for the project logistics. Founded in 1997, Hearts & Hammers-Twin Cities provides free exterior home-improvement assistance for low-income seniors, disabled, or veteran homeowners so that they may continue living independently in their own homes. A typical Hearts & Hammers home is rehabbed by volunteers in just one day to restore the character, weatherproofing, security, and accessibility of each house. Recipients benefit by having their homes, which is usually their biggest asset, restored to a safe, secure, and livable condition. Neighborhoods benefit when deteriorating houses and yards transform overnight into attractive and well-kept homes.

Twin Cities Habitat for Humanity, A Brush with Kindness **\$10,000**
City of Roseville-wide **CDBG**

This program is designed to help vulnerable (low-income senior, disabled and veteran) adults across the City of Roseville address outstanding housing violations, including emergency violations that could lead to the immediate condemnation of a home. Residents are eligible to apply for Program funds if they are working with the City of Roseville and have outstanding housing orders. City staff will work to exhaust all other available community-based, government, etc. resources prior to referring the resident to the Program to resolve the outstanding orders and/or emergency which has the resident facing potential condemnation of their home.

Twin Cities Habitat for Humanity, Single-Family Acquisition and Rehab **\$150,000**
Suburban County-wide **CDBG**

Habitat for Humanity will use CDBG funds to acquire and rehab single family homes in suburban Ramsey County outside of the City of Roseville. Homes will then be available for purchase to Habitat-eligible homeowners.

Hammer Residences, Scattered Site Home Revitalization **\$148,000**
Suburban county-wide **CDBG**

Hammer Residences is a non-profit that provides permanent housing for residents with physical disabilities in scattered site single-family homes. Hammer Residences request rehabilitation funding for to renovate up to 6 single family homes in suburban Ramsey County.

Slipstream Inc., Manufactured Homes Critical Repair Program **\$225,000**
Suburban county-wide **CDBG**

The Critical Repair Program (CRP) is administered by Slipstream and Rebuilding Together Minnesota are mission-based nonprofits specializing in creating healthier and safer homes. Through the CRP, we help scale solutions that empower people living with low incomes to reclaim their strength by improving the living conditions of their homes and, in many cases, lowering their energy burdens as a

byproduct of improvements.

**Community Action Partnership of Ramsey and Washington Counties (CAPRW),
Single-Family Home Critical Repair Program and Rehab Activities** **\$150,000
CDBG**

The program will provide grants (up to \$5,000) to low-income, single-family homeowners in suburban Ramsey County that need health and safety-related housing repairs. In addition to the repair grants themselves, the funds will cover the Agency's administrative costs to run the program and salaries for a 0.2 FTE Coordinator to assess the repair needs and determine the project scope for each home and 0.1 FTE Program Specialist who will manage applications, eligibility, and contractor relationships. With these funds, CAPRW intends to serve 30-32 households.

Public Services

Tenant Hotline- HOME Line **\$39,937**
Suburban county-wide **CDBG**

HOME Line has been working in suburban Ramsey County for the past sixteen years by providing renters a free and confidential legal hotline. HOME Line anticipates assisting approximately 800 suburban Ramsey County renter households over the hotline during the program year. They anticipate preventing over 70 evictions and saving renter families more than \$85,000 in security deposits and rent abatements. In 2021, nearly all suburban Ramsey County callers (91%), had incomes less than 80% of the area median income. The most common reasons Ramsey County residents call the hotline are repairs, evictions, and security deposits. Residents who speak Hmong, Somali, or Spanish can call HOME Line to speak to tenant advocates and receive assistance in their primary language. Calls typically, last for one half hour and the average cost is \$60.73 including direct costs, training, and supervision.

MN One Stop for Communities, Program Services **\$40,000**
Suburban county-wide **CDBG**

Minnesota One-Stop for Communities, a nonprofit organization, provides services to include an holistic, intensive case management service with the main outcome of increasing household income. Increasing the household's income is a sure way to prevent future homelessness or housing crises. MN One-Stop proposes to work with 175 households, or 490 individuals per project year. The population we will work with are households with an annual income at or below 80% AMI, are experiencing long-term homelessness, are families and individuals, and most individuals served identify as African American or American Indian. MN One-Stop will offer the following on-site activities to program participants: tenant skills, financial literacy (budgeting, goals, resources), preparation for employment (driver's license, job search, job skills training), education (GED, higher education), personal wellness (safe, stable, healthy relationships, connected to a caring network of support; increased protective factors; physical health; mental health; sobriety and recovery, healthy nutrition, healthy life choices, legal resources), and recreation, arts and crafts.

HousingLink, Rental Housing Search **\$19,000**
Suburban county-wide **CDBG**

Housing Link will reach nearly 13,000 suburban Ramsey County renters through the Housing Search tool at housinglink.org. As the region's primary source for easily accessible rental listings, HousingLink has established itself as an essential resource for lower-income Ramsey County renters seeking affordable housing. Through the customized Housing Search tool, Ramsey County residents will find rental listings

that meet their needs, preferences, and goals and help HousingLink fulfill its mission of connecting people to affordable rental homes, increasing choice and access for all.

Open Arms of Minnesota, Nutrition Program **\$20,000**
Suburban county-wide **CDBG**

Open Arms’ Nutrition Program pairs homemade, medically tailored meals with nutrition education and counseling; this model ensures that clients receive both the nutrition and the information they need to improve their health. Funding provided through the Ramsey County CDBG will allow Open Arms to expand the program and provide approximately eight months of weekly medically tailored meal delivery services to critically ill clients living within Ramsey County. Funds will support the preparation and delivery of 10,000 meals, delivered free of charge to the homes of community members living at the intersection of severe illness and food insecurity.

White Bear Area Food Shelf, Food Support **\$20,000**
Suburban county-wide **CDBG**

The White Bear Area Food Shelf’s Curbside Pick-up Food Program will serve the White Bear Lake and surrounding Ramsey County residents’ food insecurity needs. In 2022, White Bear Area Food Shelf served 23.9% more Ramsey County residents than it did in 2021. White Bear Area Food Shelf is also experiencing a 40% cost increase in the food it bulk purchases from a metro food bank due to the high inflation rates of 2022 and 2023. This project will assist White Bear Area Food Shelf in purchasing food to meet the increased food insecurity service it is providing in suburban Ramsey County.

Keystone Community Services, Food Support **\$20,000**
Suburban county-wide **CDBG**

This project will distribute food to low- and moderate-income Suburban Ramsey residents Keystone’s food shelves, two food mobiles that visit 12 Suburban Ramsey distribution sites on a regular monthly schedule, and food shelf home delivery to 30-40 Suburban Ramsey older adults and people with disabilities each month. The rising cost of food is hitting low-income households hard and many households that have never sought assistance before are turning to Keystone to help them put food on the table. Suburban Ramsey residents showed a 77% increase in Keystone food support visits from January 2022 to December 2022.

Interfaith Action of Greater Saint Paul, Department of Indian Work Food Shelf **\$20,000**
Little Canada, MN **CDBG**

The Department of Indian Work (DIW), a key program of Interfaith Action, was established in 1952, and has the only culturally specific food shelf for American Indians in Ramsey County. DIW is located in Little Canada, MN and serves residents and American Indians living in the Ramsey County area of the Twin Cities. Eligibility requirements include household income at 300% of federal poverty level. This year, DIW will serve 3,000 people through our culturally specific emergency food shelf with qualified families receiving food that will last for 3 to 4 days. DIW will distribute 250,000 pounds of food utilizing a choice model; this equates to 208,333 meals. In addition to the food shelf, DIW has a trauma-informed, student-centered afterschool and summer program for American Indian youth; a clothing closet; social service referrals, a Family Education Diabetes Series and screenings for public benefits.

Multifamily Housing Development/Preservation

**Reuter Walton, Rice Street New Rental Construction
Little Canada, MN**

**\$431,822
HOME**

Reuter Walton is proposing a 175-unit building in Little Canada at the intersection of Rice Street and Delmont Avenue. The development will include 1 bedroom, 2 bedroom and 3 bedroom units. Reuter Walton is proposing a mix of affordability levels including apartments affordable to residents at 30%, 50% and 60% of the area median income.

**Enclave, Rice Street Crossing New Rental Construction
Little Canada, MN**

**\$400,000
HOME**

Enclave is proposing a 273-unit building in Shoreview at the intersection of Rice Street and I-694. The development will include efficiencies, 1 bedrooms, 2 bedrooms and 3 bedroom units with a mix of affordability. Enclave is proposing that 20% of the units will be income-restricted at 50% of the area median income. The remainder of the units will be market rate. The development will also include public space and 10,000 square feet of retail space.



It will also be available online and linked via: ramseycounty.us/PublicHearings The 2023 Annual Action Plan will be considered by the Ramsey County Housing and Redevelopment Authority on May 9, 2023, immediately following the County Board meeting in the Council Chambers, 15 West Kellogg Boulevard, Saint Paul. The purpose of the public comment period and hearing is to receive comments from the general public concerning the proposed housing and community development needs and objectives of Ramsey County and the proposed use of FY 2023 CDBG, HOME Investment Partnerships Program (HOME), and available, if any, Program Income derived from CDBG and HOME. If the CDBG entitlement award amount increases prior to the start of the fiscal year, then 100% of the award increase will go to Slipstream's Manufactured Home Critical Repair Grant project. If the CDBG entitlement award decreases than the awards of all projects will be proportionately adjusted downward to reflect the new allocation. The proposed budgets for the uses listed in this notice are an estimate based on the allocation received by Ramsey County and the Dakota County Consortium in Fiscal Year 2023.
