Background and Rationale

The mission of Metropolitan Mosquito Control District (MMCD) is to promote health and well being by protecting the public from disease and annoyance caused by mosquitoes, black flies, and ticks, in an environmentally sensitive manner.






West Nile Virus

West Nile virus in 2023:

- 27 cases in Minnesota, 1 fatality
- 129 sample pools of mosquitoes collected in the District tested positive for WNV, which was a new record high infection rate.

What was different about 2021-23?

- Despite record drought and low mosquito numbers overall, WNV infections were higher than the preceding, high-precipitation years.
- People were likely less cautious, not wearing bug spray because of fewer annoyance mosquitoes.
- Catch basins were holding water and containers were plentiful.

Other Diseases

Jamestown Canyon virus

Found in spring mosquito species.

La Crosse encephalitis

 Found in treehole mosquitoes and impacts young children.

Eastern equine encephalitis

Rare, but highly deadly mosquito-borne disease.

Dog Heartworm

Transmitted by summer floodwater mosquito.





Integrated Pest Management

- Mosquito control decisions should be driven by surveillance – identify species, abundance, and location.
- A Technical Advisory Board (TAB) reviews MMCD practices annually. TAB members include representatives from the U of M, state agencies like the Department of Health and DNR, and federal agencies like U.S. Fish and Wildlife Service and EPA.
- Read full TAB Reports on our website.



Monitor / Surveillance

- Monitor wetlands for presence of mosquito larvae.
- Use mosquito traps and sweep net collections for adult mosquitoes.










Identify

- MMCD Entomology lab in St. Paul works with the field to identify larval and adult mosquito samples brought in.
- Larval samples are identified to determine if they are species that merits treatment.
- Adult samples are identified in part to determine if there are disease vectors present in an area.
- Some species are tested for disease at MMCD.





Surveillance in 2023



Early spring surge, then continual decline due to dry weather.


Record number of phone calls in late May – 300+ in a single day.


Heavy snowfall was likely the contributor to the spring surge.

Identify – Maps Example





- Maps give an idea of mosquito abundance in parts of the district.
- Maps can also ID by species and show the presence of disease vectors.

Control Methods

3 Primary Methods:

- Larval Control
- Adult Control
- Reduce Breeding Habitat
- MMCD prioritizes larval control because control materials are specifically designed for mosquitoes.
- Larvae are concentrated in a breeding site vs. adult insects.
- Minimal non-target effects.
- Geographical advantage (we have a larger service area).



2023 Season Overview

- Summer of 2023 brought a third consecutive year of below average precipitation with much of the state under drought conditions.
- Near record snowfall in the winter of 2022-23 brought excessive standing water in the spring which led to above average adult mosquitoes in May and early June. Mosquitoes were below average for the rest of the summer.
- There were 13 cases of West Nile virus 1 case of La Crosse encephalitis in the District.
- Deer ticks were once again collected in every county in the Metro.
- Average black flies collected per sweep were higher than 2022, but below the 15-year average.

Plans for 2024


- Expand service area for mosquito, black fly, and tick surveillance and treatment based on weather, population changes, and other factors.





Figure 1.15 Average seasonal rainfall per gauge, average number of *Coquillettidia perturbans* in CO₂ traps, 2000-2022, and predicted amounts for 2017 and beyond.



WORK SUMMARY: MOSQUITOES, BLACK FLIES, TICKS

MOSQUITOES

For the third consecutive year the Twin Cities area experienced drought conditions throughout most of the summer which contributed to lower levels of annoyance mosquitoes. Near record snowfall during the winter of 2022-23 brought standing water in the spring, which ushered in a surge of mosquitoes exceeding the 10-year average in late May and early June. Lack of rainfall in the subsequent months led to a decrease in the mosquito population and it remained low through the rest of the summer.

West Nile virus was active in the District and elsewhere in Minnesota in 2023. Testing of mosquitoes for WNV returned the highest rate of infection in the history of the District's WNV surveillance. One hundred twenty-nine of 818 mosquito samples tested were positive for WNV. While most human illnesses have been reported, some are still being evaluated. As of January, 27 WNV illnesses had been confirmed in Minnesota with thirteen of those cases in residents of the District. As of January, illnesses caused by two other mosquito-borne viruses had been reported in Minnesota. Two Jamestown Canyon illnesses were confirmed in residents of Anoka County and Ramsey County. One case of La Crosse encephalitis was confirmed in a resident of Scott County. For more information about vector-borne disease in 2023 look for the MMCD Technical Advisory Board report coming in the spring of 2023.

BLACK FLIES

MMCD employees controlled immature black flies (biting gnats) in small streams and large rivers throughout the metropolitan area. In 2023, 121 black fly larvicide treatments were made to the rivers and streams in the District. Spring flooding caused a slight delay in sampling efforts. After the extremely high-water levels in May, the continuing drought in the area caused rivers to go well below average through September resulting in few treatments after June. Adult black flies remained at tolerable levels for most of season with the number of black fly annoyance calls in 2023 (46), higher than 2022 (11) but less than 2021 (151).

LYME TICK SURVEILLANCE:

Staff continued sampling established sites distributed throughout Ramsey County and elsewhere to monitor changes to the deer tick population. A comprehensive 2023 Lyme tick surveillance report will be available later in 2024. Numbers of deer ticks (*Ixodes scapularis*) have risen over time.

<u>Lyme disease cases statewide</u>: Human tick-borne disease cases tabulated by the Minnesota Department of Health (MDH) have also been on the rise since 2000 with Lyme case totals typically >1,000 yearly.

<u>Signage at dog parks and expansion into new areas.</u> Since 2010 we have posted signs of general deer tick information at approximately 21 dog parks across the metro. Please call if you have a location that you would like us to consider for sign posting.

PUBLIC EDUCATION AND OUTREACH:

MMCD continued to expand our educational offerings in 2023 in the form of in-person presentations delivered to schools and community groups. Throughout 2023 we delivered classroom presentations to 22 schools across the District serving elementary, middle, and high school students.

MMCD's attendance at community events continued to increase in 2023 including a few new occasions. The biggest event of the year was the Minnesota State Fair where District staff had conversations with over 9,600 people during the 12-day event. MMCD also attended county fairs in Anoka, Dakota, Carver, Scott, and Washington counties and added new events like Grand Old Day in St. Paul the Great Minnsect Show at the University of Minnesota. We participated in 21 parades throughout the District in 2023 where we featured our mosquito mascot "Vectoria."
