Land Acknowledgement

Every community owes its existence and vitality to generations from around the world who contributed their hopes, dreams, and energy to making the history that led to this moment. Some were brought here against their will, some were drawn to leave their distant homes in hope of a better life, and some have lived on this land since time immemorial. **Truth and acknowledgement are critical to building the mutual respect and connection across all barriers of heritage and difference.**

We are standing on the ancestral lands of the Dakota People. We want to acknowledge the Ojibwe, the Ho Chunk and the other nations of people who also call this place home. **We pay respects to their elders past and present.** Please take a moment to consider the treaties made by the Tribal Nations that entitle non-Native people to love and work on traditional Native lands. Consider the many legacies of violence, displacement, migration, and settlement that bring us together here today. And please join us in **uncovering such truths at any and all public events.**

The Results of Policy & Systems

- Approximately 3,200 of the 11,000 American Indians in Ramsey County are living in poverty (29%)
- 4 out of 10 American Indian households in the East Metro receive SNAP
- 1.8% of American Indian population had an active MFIP case compared to 0.20% of white population in October 2024
- Just 1 out of 10 American Indian families in the East Metro are homeowners
- American Indian individuals are overrepresented in the Adult Detention Center at 3.3% of bookings while making 0.60% of the population in Ramsey County (2019)
- American Indian children reenter and age out of foster care at a higher rate than any other group (2024)
- The unemployment rate for American Indians in the Twin Cities Metro Area was 8.4% compared to 4.0% rate for total labor force in 2022

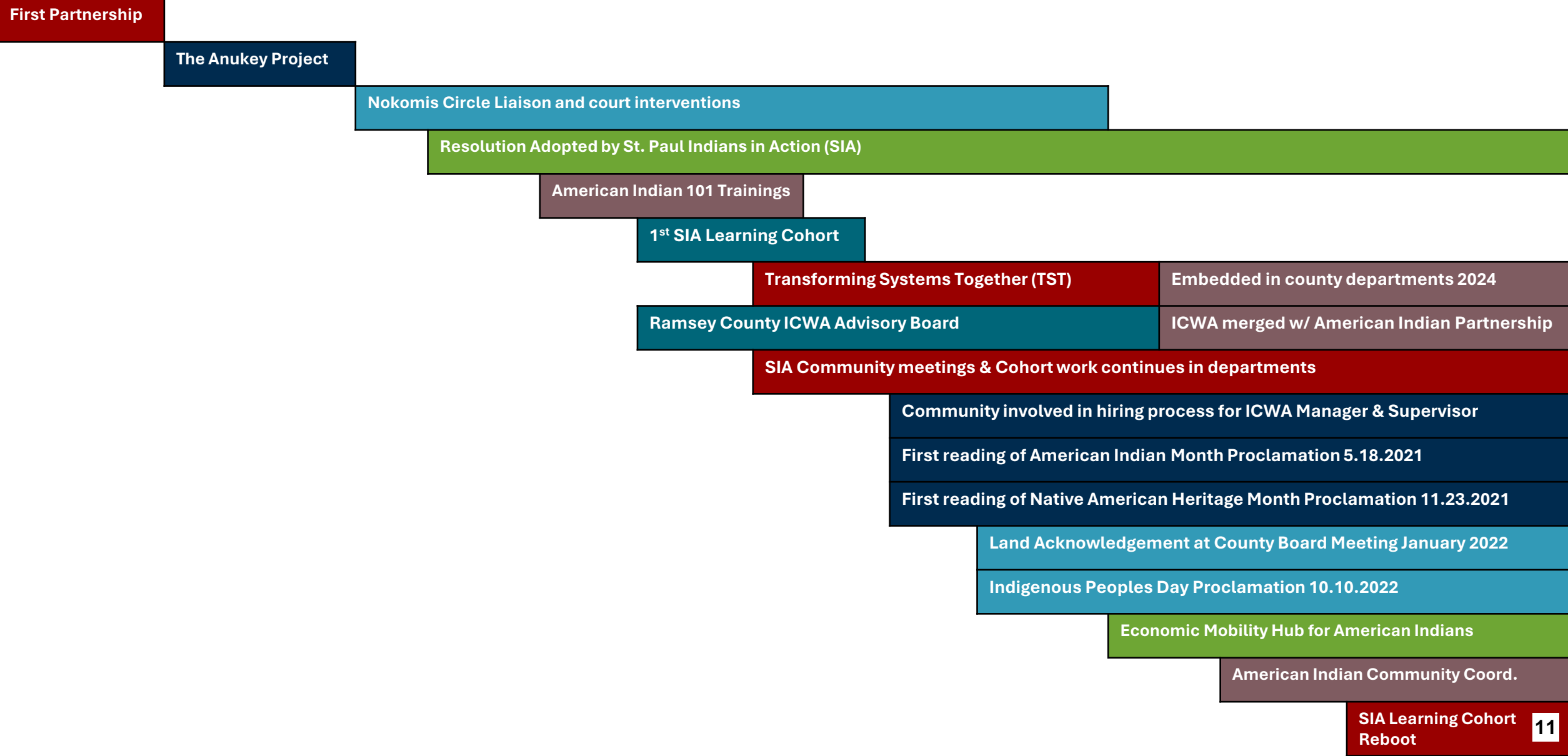
