Background and Rationale

As provided in Minnesota Statutes Chapter 401, the Ramsey County Corrections Advisory Board (CAB) actively participates in the formulation of the comprehensive plan for the development, implementation and operation of the correctional program and services described in Section 401.01, and makes a formal recommendation to the County Board at least annually concerning the comprehensive plan and its implementation during the ensuing year.

The CAB consists of at least nine members who, as required by Statute, are representative of law enforcement, prosecution, judiciary, education, corrections, ethnic minorities, and social services.

There are five members on the CAB whose terms expire on December 31, 2020. Recruitment through the County's Open Appointment Process resulted in four applications. On November 6, 2020, the Chief Clerk's Office forwarded the applications to the Board of Commissioners for review and recommendation.
